6. Report seeking authority to settle a claim against the City Council

RECOMMENDED that the City Solicitor be authorised to agree terms of settlement and conclude the litigation against the City Council as set out in the exempt appendix.

#### 7. Exclusion of Press and Public

The public interest in maintaining the exemption must outweigh the public interest in disclosing the information.
