11 Notices of Motion

(a) Proposed by Councillor Jason Fazackarley Seconded by Councillor Sandra Stockdale

Each year an estimated 10,000 ex-racing greyhounds are 'unaccounted' for - puppies that don't make the grade, dogs that sustain injuries, are pregnant or unable to find homes, most are less than five years old.

Many of these dogs are disposed of in the most 'economical' way - by bolt gun.

Until fairly recently there existed a Greyhound Stadium in Portsmouth and it is right that concern is expressed for the welfare of the dogs that were used at that venue. Raising concerns for these dogs, as well as others across the UK, can be highlighted by the passing of this motion and representation being made to DEFRA and central government.

Portsmouth City Council calls on the government to outlaw the use of bolt pistols to kill greyhounds.

Under existing UK legislation, any person can use a bolt gun to destroy a greyhound, if they are the legal owner. Attempted destruction of greyhounds by bolt has resulted in innocent dogs being left to suffer in agony for hours, before being found and taken to a veterinary surgery to be finally put to sleep by lethal injection.

These dogs should at the very least be entitled to a humane death. Destruction of greyhounds should only be performed by use of intravenous euthanasia, administered by qualified veterinary surgeons.

Following the controversial use of bolt guns by RSPCA inspectors a few years ago, the RSPCA requested the Royal College of Veterinary Surgeons (RCVS) comment on their review of its 2004 euthanasia rules and guidelines. In April 2010 the RCVS announced that use of the captive bolt guns on dogs was inappropriate

DEFRA have the power to end this cruel practice so we are calling on them to immediately abolish the use of captive bolt guns to destroy greyhounds in the UK.

(b) Proposed by Councillor Ken Ferrett Seconded by Councillor John Ferrett

Council Notes -

- A number of construction companies have been challenged about supporting the existence of and subscribing to construction industry 'blacklists',
- These 'blacklists' detail covertly and potentially illegally gathered information on trade union members in the construction industry.
- The construction industry blacklist was collated by the Consulting Association (a private consultancy) and was then provided at a cost to construction companies as they sought to recruit/avoid new workers.
- The construction unions are leading a national campaign aimed at forcing those who have been involved in blacklisting to apologise and provide compensation to those who have found it impossible to work in construction as a result of this blacklisting.
- The Information Commissioner has investigated and taken action against the Consulting Association for this practice.
- The Information Commissioner has also taken enforcement action against a number of construction companies based on the evidence recovered from the Consulting Association.

Council Believes -

- Blacklisting is a malicious and unacceptable practice and cannot be condoned.
- Construction workers should be free to belong to a Trade Union and raise legitimate safety concerns in what is a hazardous industry.
- Owing to the concentration of construction activity in and around cities such as Portsmouth, significant numbers of our residents have undoubtedly been disadvantaged by this practice
- Blacklisting has ruined careers and lives, not only of construction workers but also those of their families.

Council Resolves -

 To support the trade union campaign for justice for those affected by blacklisting.

(c) Proposed by Councillor Luke Stubbs Seconded by Councillor Donna Jones

As public bodies, local authorities have both a moral and a legal duty to respond to the wishes of their residents. Countless examples from around the country make clear that this does not always happen in practice, but nevertheless it should.

While acknowledge its own shortcomings, this council nevertheless considers consulting and engaging with the public to be of paramount importance. It recognises the potential new technology provides to simplify communication with the people of the city.

YouChoose is a free-to-use consultation tool provided by YouGov, initially for use by the London Borough of Redbridge, which has been adopted by around 50 other authorities nationwide and has a track record of eliciting high levels of responses from the public.

This council considers it worthwhile to acquire this (or similar) software and directs officers to use it as the basis for a consultation in advance of the 2014/15 budget meeting.

There is a small charge of about £1000 for the YouChoose data tables and any rival products are likely to give rise to a similar bill. This should be more than offset by savings that can be made to more traditional forms of consultation, but if there is any net cost it should be met from reserves.

12 Forward Plan Omission Report Portsmouth Football Club – Financial Loan Support to Portsmouth Supporters' Trust (PST)

To note in accordance with the Constitution that due to the urgent decision that needed to be taken at the Cabinet meeting on 27 February 2013, in relation to entering into a loan facility agreement (subject to conditions) with the Portsmouth Supporters Trust (PST) to enable PST to make a bid to acquire the assets and business of Portsmouth Football Club (the Club), it was consequently not possible to include the item within the normal forward plan process and the usual omission procedure therefore had to be followed.
