The report by the Head of Transport and Environment.

This report has been requested by the Leader of Portsmouth City Council

following the decision made at the Traffic and Transportation meeting of the 19<sup>th</sup> February. The paper sets out to agree a way forward to address the continued congestion of traffic travelling on the Rudmore Roundabout on slip to the M275 towards Mile End. Concerns have been raised by the Leader of the Council about the wider impact to the city due to the congestion entering the city during peak times, the impact it is having on businesses and the reputation it is having on attracting investment in the city.

#### 4 Anchorage Park Weight Restriction (Pages 23 - 26)

The report by the Head of Transport and Environment.

There have been further representations from residents on the use of HGVs on Anchorage Road between the roundabout of Anchorage Road / Robinson Way / Sywell Crescent and the roundabout of Anchorage Road / Norway Road / Williams Road. The purpose of this report is to review the current status of the road following the installation of improved surfacing and consider installing a full time weight restriction.
