#### 11. Notes of the Previous Meeting of 14 March 2017 and Matters Arising.

## 12. Workforce Futures (Developing a new workforce strategy for the Solent area).

Stuart Baker, Head of Local Growth at Solent LEP introduced the report and provided a short presentation.

The Chair thanked Stuart for his presentation and invited comments and questions, which included the following points:

- It is essential that businesses are asked to identify what skills are currently lacking and those that will be required in five years' time.
- The UTC in Portsmouth is now open. During the process, they were almost forced to adopt a multi academy trust as a model.
- Employers in the area have sent a clear message to central government that they want local influence. It is therefore essential that local employers and education providers work together.
- Employers are telling us that there is limited talent coming through.
- There are two workshop sessions taking place on 31 October at the Hilton Ageas for providers and employers.
- Members are encouraged to give their views either at the meeting or afterwards by email.
- The implications of Brexit on skills supply in the Solent will be considered as part of the work programme, but it is acknowledged that the nature of the deal the UK government strikes with Europe is likely to continue past the delivery of this strategy.

#### 13. Local Growth Deal Capital Programme Update

Marc Griffin, Head of Capital and Infrastructure at Solent LEP provided an update on the 2017/18 Local Growth programme. This was followed by a presentation on the Local Growth Deal funded capital projects delivered to date in the Solent LEP area. During the presentation members were asked to note that to date the Solent LEP has provided over £80m of capital funding to deliver local growth deal projects to support economic growth including transport, skills, innovation and housing infrastructure projects. He also informed them that the funding finance and performance management group will consider the options available to address the under allocation of funds currently reported for this year at its meeting in November 2017 for recommendation to the Board for their approval at December 2018.

#### 1. Purpose of report

This report provides an update to the Solent Growth Forum on the Local Growth Deal (LGD) programme which is investing in capital projects in the Solent area to support economic growth.

The Solent Growth Forum can find background information to the Local Growth Deal at Solent Growth Deal 1, Solent Growth Deal 2 and Solent Growth Deal 3 links.

#### 2. Local Growth Deal Programme Status

The Local Growth Deal programme continues to progress in 2017/18. Table 1a below shows the forecast for 2017/18 which was considered by the Solent LEP Board on 7 March 2018. The approved capital programme either under negotiation or at funding agreement stage is £27,813,973, which is 90.6% of the total funding available for allocation in 2017/18.

The Solent Growth Forum should note that following the mid-year review the forecast defrayal of funding approved in the current year is lower as shown in table 1b. The forecast expenditure is £16,304,307 which is 53.1% of the total funding available to spend in 2017/18. It should be noted that some of the schemes in the capital programme for 2017/18 will continue into 2018/19. Therefore, funding that has not been defrayed will be re-profiled into 2018/19 to facilitate the delivery of these schemes. This is reflected in the budgets for 2017/18 and 2018/19 as set out in the financial forecasts and under table 2 of this update which the board approved.

**Agenda Item 5:** Strategy Update

This agenda item will provide a presentation to the Solent Growth Forum (SGF) to update on the work in train on the new strategy by the Solent Local Enterprise Partnership (LEP). This paper provides a summary of what will be covered.

The Solent Local Enterprise Partnership (LEP) is progressing a range of strategy work and updates to its evidence base, which will feed in to the development of a new Strategic Economic Plan for the Solent and a Local Industrial Strategy.

Recent completed strategy work includes:

- Economic Impact of the Solent Area Universities (a high level summary of this study is provided as appendix 1)
- The economic role and contributions of the maritime sector in the Solent
- Isle of Wight Infrastructure Investment Plan

The Economic Impact of the Solent Area Universities was launched at the recent LEP Annual General Meeting, whilst The Economic Role and Contributions of the Maritime Sector in the Solent report and the Isle of Wight Infrastructure Investment Plan will be published shortly.

The LEP is updating the Solent Strategic Transport Investment Plan (a copy of the STIP can be found here: https://solentlep.org.uk/media/1514/tip-final-web-version.pdf.

In addition, the LEP is progressing the development of a Heat and Power Strategy and Action Plan for the Solent.

The above work will be covered in the presentation under this agenda item at the Solent Growth Forum.



# Jobs, growth and world-leading innovation:

## Our universities' economic impact

The Solent's three universities are together injecting more than £4.2 billion into the UK economy every year, supporting 52,300 jobs.

That's the key finding of a major study on the combined economic impact of the University of Southampton, the University of Portsmouth and Southampton Solent University.

Research by BiGGAR Economics also revealed the universities' localised impact on the Solent LEP region: £2.1 billion of economic value, sustaining 33,000 jobs.

The contribution, known as GVA or 'Gross Value Added', takes into account factors such as staff and student spending, income for supply chain companies, business services and the commercialisation of university research.

The study showed that every £1 the universities generate from their own work sustains £6 worth of UK economic

activity, with £3 of that retained in the Solent LEP area.

And for every person they directly employ, the universities support more than five jobs in the UK, including three in the Solent.

The report highlights world-leading university research going on in engineering, biomedicine, aerospace, defence, marine, maritime and advanced manufacturing.

Investment by each university to assist small and mediumsized business has helped to put the region well above the national average for creating high-growth firms.

Examples of the universities' 'knowledge assets' include the University of Portsmouth's Future Technology Centre and the clustering of tech firms around the University of Southampton's Chilworth Science Park.
