**44160323728 - 44160323330 28/08/2016 04:00 – Assault – (Saturday – Sunday)**

Male walks into licensed premises and is involved in a dispute which escalates into a fight.

Both parties are interviewed and later no further action is taken following an investigation into the incident.

**44160384005 05/09/2016 02:17 – Public Order (Sunday – Monday)**

Male seen in the premises to become involved in a dispute with another male. He takes his shirt off and begins to make threats to others.

Male is arrested and later issued with a penalty notice for disorder.

**44160371855 02/10/2016 04:25 – Common Assault (Sunday – Monday)**

Informant reporting that as he is leaving the premises another person kicks some food out of his hands. The foot connected with his hands causing no injury but shocking the victim.

This is the incident potentially past hours.

**44160387902 14/10/2016 02:57 – Common Assault (Friday – Saturday)**

Males become involved in an argument at the premises. This spills out onto the street and both males are aggressive towards each other. Police attend and disperse both parties.

**44160404007 26/10/2016 02:48 – ABH (Wednesday – Thursday)**

Female has a can of drink thrown at her by an unknown male causing injuries to her.

Police are investigating the matter. Currently the venue have lost the initial CCTV recording of the incident.

**44160409639 30/10/2016 02:36 – ABH (Sunday – Monday)**

Two females argue within the premises and then begin fighting. Police attend. No one wishes to make any complaint. Both parties are dispersed by Police.

**44170025615 21/01/2017 00:46 – ASB – (Friday – Saturday)**

Informant is a staff member and has reported that male has attended the premises, been argumentative and aggressive towards staff. Police attend but the male has left prior to any Police attendance.

**44170037117 29/01/2017 23:39 - Assault – (Sunday- Monday)**

Staff member assaulted at the premises by offender. Offender enters the premises and begins an argument with the staff member. The staff member comes from behind the counter and is seen to push the offender. Both go to the rear of the premises where the staff member is assaulted by the offender.

On investigation into this matter it transpires that the staff member had been convicted of Affray and sentenced to Prison following the incident where staff attacked two customers leaving one with GBH level injuries.

**44170053775 - 11/02/2017 02:25 – Assault (Friday – Saturday)**

Female with group of friends asked to leave the premises. Door staff from a local premises assist as they believe that the door staff employed are struggling to communicate effectively with the group. On being ejected one of the females alleges that she has been sexually assaulted by the door persons assisting. The is later found to be the unfortunate placement of hands rather than an offence and no further action is taken.

**44170054885 – 12/02/2017 00:30 – Assault (Saturday – Sunday)**

Male begins throwing chips around and is asked to leave by door staff. On leaving the male punches a door person from another premises assisting, in the face.
