Dear Debra

I am writing to you regarding the proposed licensing application submitted by South Parade Pier.

I have been the General Manager for 20 years at the Ocean Hotel & Apartments and I am extremely concerned for our future Hotel Guests and of course the residents of the Ocean Apartments should the South Parade Pier be granted an alcohol and entertainment licence.

Before the pier closed down every week-end was a problem for us and surrounding neighbours with the noise and unruly behaviour of people leaving the pier, no consideration was ever given to the surrounding neighbourhood at that time no matter how many times we complained.

When visitors to the functions on the pier were fuelled with alcohol we suffered noise until 1.30a.m. on many occasions until much later. Taxis coming and going outside the pier and bus stops and many drunken people hanging around shouting, swearing and leaving

so much rubbish that our first job every morning was to clear up our patio. The rowdy behaviour was EVERY weekend and if there was a particular event on the pier and they had an extended license no one in our sea-facing rooms and apartments managed any sleep until about 2.00 – 3.00 a.m.

We were also used as a urination pit stop. This did have a huge effect on our business due to the rowdiness in the early hours of the morning, as we offer many sea-facing rooms and suites, guests staying during this time did not get a good night's sleep and the reception staff then had to pacify guests the following morning. Our repeat business suffered dramatically. Since the pier has not been in operation we have no complaints and our repeat business is now excellent. We will lose this business and we will be back to guests complaining due to the constant late night noise.

The bus stops that are directly outside the Hotel were often used as pick up points for taxis, as it was always difficult for them to park outside the pier and that has not changed. Quite often the Bus Shelter Glass/Perspex was smashed. The area has also majorly changed since that time, all the night clubs have gone and many more residential accommodation has been built. This accommodation is mostly the older generation who come to Southsea to enjoy a peaceful way of life. The type of residents in this area now are not the type to stay out late drinking, therefore the type of clientele that will be attracted to the pier will be the younger generation who enjoy drinking and partying until all hours, if they are allowed to. I wonder how long it will be before the Live Music and Club atmosphere take over as the main events on the pier. Once alcohol has been consumed for a number of hours it fuels unruly behaviour which we do not need or want in this area.

I can remember an article written by the owners of South Parade Pier as they took over to say they wanted to bring back the Pier for Family entertainment and somewhere you could take your children safely. I do not consider that many families will take their children if alcohol is being served until the very early hours of the morning. The Family orientated Pier that we initially approved of, it seems will now not be the case. If the residents of the local area had realised we were going back to even longer licensing hours I think all of them would have objected strongly at the time. The pier owners will not be able to contain the noise as the outside walkways of the pier will be open to the public. The outside area will be the only place that the smokers presumably can smoke, they will take their drinks out with them, therefore the outside area will become a place for people to gather.

To go back to the noise, unruly socially unacceptable behaviour and the incidents of crime that we suffered before when the pier was open (i.e. cars had their wing mirrors broken off and it was always great fun for the drunken to bend the windscreen wipers and Scratch cars paintwork). This was a common occurrence for residents and guests of the Ocean Hotel & Apartments which we do not want to happen again. Since the Pier has been closed we have

only had one incident which was a drunken driver who smashed into a car. As a business we also had our main windows smashed on more than one occasion.

I am not just the General Manager of the Ocean Hotel & Apartments, I live in 29B South Parade just past the Clearwater Apartments and I know first-hand the problems with noise and disruptive behaviour also affected my flat every week-end, I could never park my car in the street due to all the extra cars that came down to the pier. I also had my back window smashed which we know was a group of revellers who had been attending the pier, as my car was not the only car with damage.

I would, please like to attend the licensing meeting to speak and explain why I am so apposed to the licensing application. Please let me know when the meeting will be held as I will have to take time from work to attend.

Dear Debra,

I am writing on behalf of the Residents Association of Clearwater Apartments, 38-42 South Parade, Southsea. Our association represents the owners and residents of 16 properties within Clearwater Apartments named below. We have been made aware of the recent Licensing Application as referenced above by the owners/operator of South Parade Pier. This application in our opinion seems to be entirely out of step with that of the surrounding area of South Parade and the seafront as it is today. We have no objection to appropriate events taking place on the Pier, however we strongly object to Licensing hours that extend to 2am and 3am in the morning. Extended hours of drinking would almost certainly see a return to the problems that all residents of this area had to endure some five years ago, which invariably led to excessive noise levels from the Pier during some events, antisocial behaviour in the early hours of the morning as people leave the venue and then often occurrences of vandalism in and around our property.

As owners of our properties, we have all invested substantially over the last 5 years in Clearwater Apartments in order to assist in bringing the building back to its once former glory and contributing as a whole to the much needed uplift in the South Parade and surrounding area. We do not now want to see a return to the negative reputation this area used to have, as a result of meeting the needs of the very few who have little or no interest in our community, or consideration for others when fuelled with alcohol.

Dear All,

I have received the leaflet through my letter box regarding the reopening of the pier. I live on the corner of Granada and Alhambra Road, so I have a big interest in what happens with the pier. I was very excited by the news in the leaflet, and it sounds like a lot of good things are coming.

The reason for me emailing is because I want to express my concern at the suggested licencing hours. The ideas of events until 3am on weekends, and the possibility of drink sales until 2am Monday - Saturday does worry me slightly. I am sure that a lot of people visiting the pier at that time of night will then use Alhambra road as a cut through to get home, and I fear there will be a lot of screaming and shouting outside my flat. This happens occasionally now, but it isn't a reoccurring issue. I am a shift worker and my sleep patterns are exceedingly important to me. I fear that these licensing hours will jeopardise this for me, meaning that concentrating on my job will be more difficult. I work in a very dangerous industry within Southsea, and getting quality sleep is very important.

I purposely chose to buy a property away from the busiest areas of Southsea, and I am worried that this is now being brought to me. A 12am finish time would be a lot better, and still allow for many events to be held at the pier. I am sure it is possible to apply for extended opening hours for special events throughout the year.

OBJECTION

Dear Sir,

I strongly object to the above licence applied for by South Parade Pier.

It is utterly outrageous to even consider that the pier should open twenty-two hours a day and cannot be considered.

When all the clubs were closed on South Parade it was because the police stated that they could no longer police the area because of Gunwharf and Commercial Road

The police force has reduced numbers of officers on duty, not increased, so nothing has changed and the police cannot attend all night to deal with the endless problems that would be caused by alcohol being served twenty-two hours a day and adult 'entertainment'.

When the clubs closed the criminal damage on South Parade and surrounding area ceased overnight and vehicle insurance, in particular, was dramatically reduced. What right does PCC have to bring back all those problems again and force huge insurance premiums on the local residents again?

PCC has spent over two-years refusing to have adult 'entertainment' on Albert Road, so what now makes South Parade appropriate?

Albert Road is essentially a commercial area but South Parade is not – in any way - it is wholly a residential area.

PCC permitted the building of a huge retirement block of apartments right opposite the Pier so how can you now licence alcohol and adult 'entertainment' in that area, particularly twenty-two hours a day?

It is bad enough that local residents have every single summer ruined by the increasing volumes and hours of events because PCC refuse to turn all the speakers West, which would not face one single residential property, but insist on facing them all West/North West facing hundreds of thousands of residential properties.

Southsea pays the lion's share of Council Tax as the majority of Portsmouth properties are A & B rated so why does PCC insist on ruining the lives of Southsea residents?

South Parade residents work hard to pay their mortgages/rents and it is not in any way acceptable to consider that they should suffer lack of sleep by licencing a premises for twenty-two hours a day and in fact any premises intending to 'entertain' adults for twenty-two hours a day should not be in a residential area.

There is no argument. If PCC consider that something far less and for far less hours/ adult 'entertainment'/off licence'/ is not appropriate on Albert Road then it most certainly is not on South Parade either and must be refused – in entirety.

If PCC consider loud music acceptable for twenty-two hours a day, why is it not licensed on Albert Road for twenty-two hours?

Stop driving us all out of our homes. Take these ridiculous, selfish, totally anti-social places out of town and plant them in areas that have nothing but commercial premises.

This has to be refused in entirety. No noise nuisance should be heard or suffered from nearby domestic property and the pier should be closed by 22.00 hours every day.

I remind you that Cllr Linda Symes ruled that licence applied for a restaurant on Grove Road South should be forced to close at 20.00 hours because the premises was opposite a couple of residential houses and again look at the refusals made on the applications for the premises Tonbridge Street/Kent Road/Portland Road because it was considered inappropriate.

No more than the twenty-two-hour opening is on South Parade.

Good Evening,

I am writing to you in response to the article featured on the leaflet 'in touch' regarding South Parade Pier.

As a local resident of St Helen's Parade, I would firstly like to express how delighted I am that the Pier has been restored as it is an important landmark of historical importance for our City. It was also lovely to see families walking along and enjoying the pier this weekend.

I understand the future of the Pier depends not only from continued investment from its owners but also through becoming a viable business in its own right. As much as I support the continued growth of the Pier I must voice my concerns as a local resident. I fully appreciate that part of its appeal is to return the Pier to an entertainment venue, but the licensing hours that have been proposed are excessive and not in-keeping with the establishments in close proximity such as the Southsea Beach Cafe.

The proposed hours will turn the pier into a late night drinking venue which is not only alarming but something I strongly oppose. As residents of St Helen's Parade we are blighted in the summer months by anti-social behaviour on Canoe Lake with drunken youths untying the boats, causing damage to property, publically urinating in the lake and causing excessive noise into the early hours. We have called 101 on numerous occasions

but with the police force so stretched within our City often they are unable to respond and we therefore don't always call them.

The extended opening hours proposed increase the likelihood of these incidents occurring and they have a detrimental impact upon residents of the local area, many of which are Business Leaders within our City. Since the centralisation of nightclubs to the City Centre the area is predominantly residential. The McCarthy and Stone Retirement development is also another factor to be considered as the extended licensing hours are in complete contradiction to this.

My husband and I fully support the Pier becoming family centric and look forward to the events that can now be held but feel the late alcohol licence (especially during the week) sends the wrong message and is detrimental to not only the Piers image but also to us as local residents.

We understand you are keen to have feedback regarding the proposed licensing hours for South Parade Pier and as local residents of St Helen's Parade, we feel it is our duty to get in touch. We would firstly like to acknowledge the benefit the restoration of the Pier has for not only the local community but for the City as a whole. We think it is fantastic that the Pier is now open again and everyone is able to enjoy such an important local landmark.

We understand the future of the Pier depends on the continued investment from its owners and also through becoming a viable business. 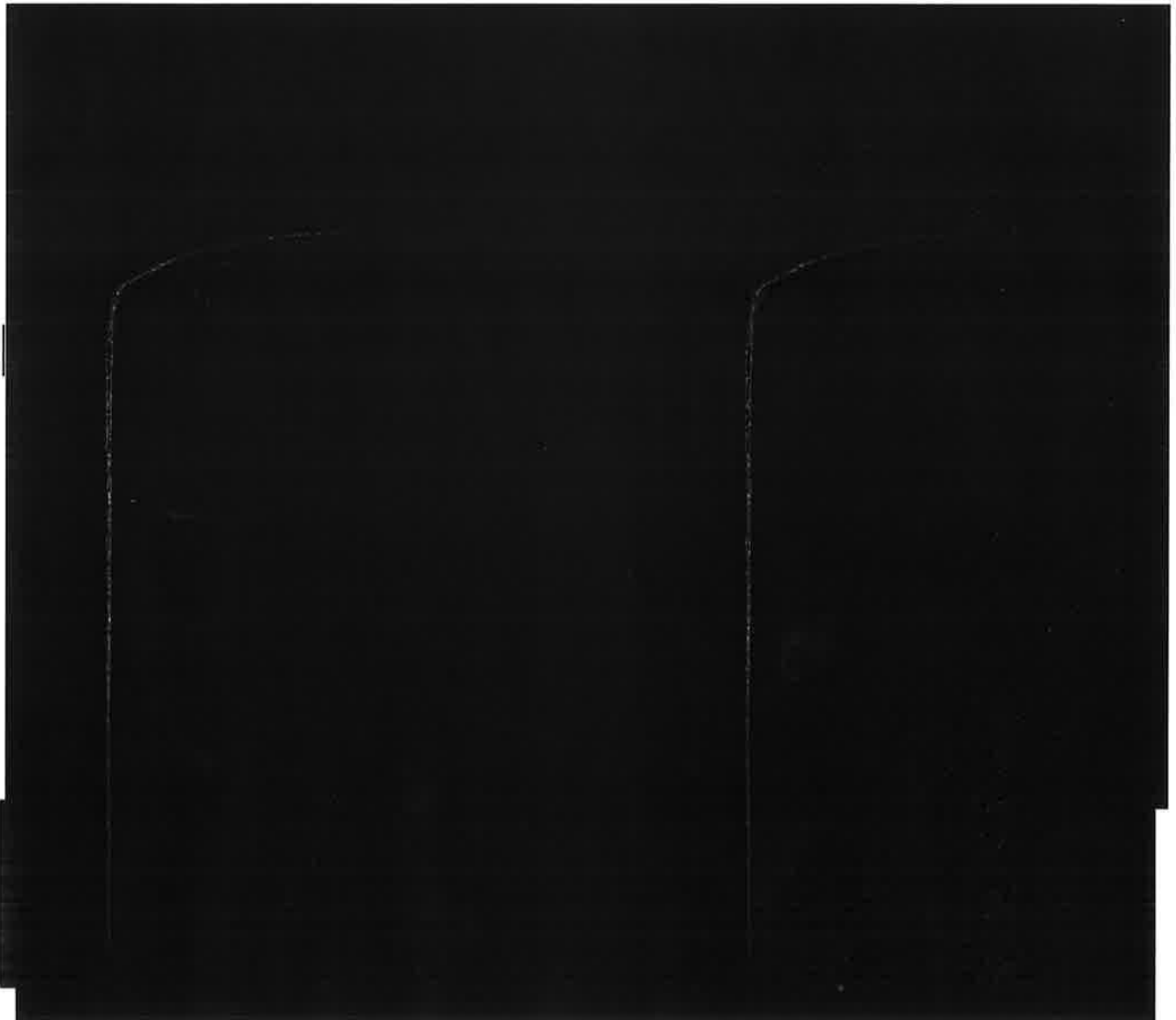

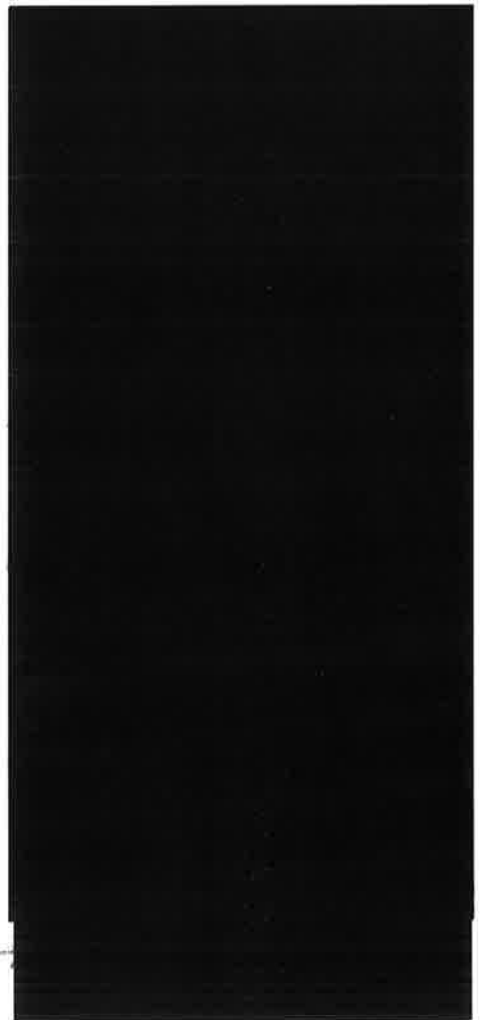
