3 The Council Housing Budget for 2011/12

... The report by the Head of Housing Management and Strategic Director and Section 151 Officer is attached.

The City Council has delegated to the Cabinet Member for Housing the functions of setting rents charges and budgets for council housing. The purpose of the report is to seek the Cabinet Member's decisions on Council housing budgets, rents and other charges, debt repayment and the funding of Adventure Play Areas and to give authority for managers to incur expenditure in 2011/12.

Approval is also sought to allow officers to consult with residents' representatives, the Cabinet Member for Housing and Opposition spokespersons and if appropriate finalise arrangements for "Self Financing" for Council Housing, including taking on extra debt in exchange for ending payments to Government under the HRA Subsidy System.

The recommendations are set out in Paragraph 12 of the report including recommendation (xi) to the City Council regarding Self Financing for council housing and any necessary borrowing required.
