 Support for Voluntary and Community Sector 2009/2010

1. Purpose of the Report:

The purpose of this report is to make recommendations on the allocation of funding for the Voluntary and Community Sector (VCS) services in the grant year 2009/2010.

2. Recommendations:

- 2.1 It is recommended that the Resources Portfolio Decision Making Meeting
 - Agree the allocation of funding for 2009/10 (set out in appendices 1-6)
 - Note the progress of the second stage of the Grants Review
 - Agree that the council should not tender for the infrastructure support service at this time, but that a three year contract should be developed with Portsmouth Council for Community Service, subject to the successful negotiation of a service specification.

3. Background

- 3.1 The council has a long standing good relationship with the VCS in the city and is well regarded by organisations within the city. The VCS is able to provide better quality locally based services to Portsmouth residents and the Local Area Agreement for 2008-2011 includes two National Indicators (NI) which recognise the value and importance of the relationship between the city and the VCS, NI 6 (Participation in regular volunteering) and NI 7 (Environment for a thriving third sector). Preliminary results of the National Survey of Third Sector Organisations which was carried out by Ipsos MORI on behalf of the Office of the Third Sector to establish a baseline for improvement in the future for NI7 shows Portsmouth to be in the top12% of councils rating statutory bodies' influence on their success as positive overall.
- 3.2 As part of its support to the Voluntary and Community Sector, Portsmouth City Council normally operate an annual grant programme. The second stage of the Grants Review, which reported to the Resources Portfolio decision making meeting on 9th October 2008 recommended that organisations currently receiving grant funding should be invited to reapply for a grant for 2009/10, but the council would not advertise an open-to-all grants programme. This decision was taken in recognition of the fact that due to budget savings grant funding has been reduced across the board over the past two years, leading to the percentage of successful applications dropping sharply from a 65% success rate in 2006/07 to 36% in 2008/09. If funding for grants is limited expectations can be raised unfairly by advertising an "open for all" programme. The closing date for applications for funding was 31st December 2008.
- 3.3 The criteria for grant aid from portfolios is attached to this report (Appendix 7) and supports each department's recommendations. All applications are held in the Democratic and Community Engagement Service and recorded on the central grants database.

- 3.4 The application form requires that bids support the themes of the LSP's Vision for Portsmouth and a monitoring form will be sent to ensure spending of the grant and progress towards targets and outcomes at the end of the year. All applicants are required to provide accounts, evidenced organisational status and reserves policy in order to be eligible to receive a grant.
- 3.5 A list of grants awarded will be posted on the Portsmouth City Council Website, together with a link to this report and the accompanying appendixes. We will continue to provide support for those ineligible to apply for grants by signposting them to suitable sources of funding, including Porsmouth4Community, the funding database which can be accessed from the PCC website, Lottery Funding and local funding streams, including Grassroots Grants, a funding programme for small voluntary and community organisations and to the Funding Advisor at Portsmouth Council for Community Service.

4. Recommendation Totals

In 2006 the grant year was moved to start at 1st July each year to allow the process to be Compact compliant. The change of the grant year means there is a commitment of 3 months funding on the following year budget allocation but also allows for 3 months notice of withdrawal of funding for any particular organisation post budget.

Whilst the information presented in the following table is presented by service all voluntary grant applications are made to the Portsmouth City Council rather than to separate services within the city council. The applications are allocated by a grants panel to a service portfolio that is considered to be the best fit and then assessed accordingly.

5 Review of the Grants Process

- 5.1 Following completion of the review of the grants process a number of recommendations which were agreed are now being actioned. This means that in future the council will continue to run a small grants programme for "seed-corn" for new initiatives and "one-off" funding. The council will also explore whether other LSP partners would like to join in creating a partnership funding programme for this.
- 5.2.1 The council is now in the process of transferring long term grant funding arrangements of over £10,000 a year for three years duration into contracts, so giving greater stability of funding to the third sector.
- 5.3 At the Resources Portfolio Meeting held on 2nd October it was agreed that the city council should make a decision by 2009 as to whether to continue to fund PCCS or whether to tender for the infrastructure support service. Following discussion with PCCS it is recommended that the council should not tender for the service at this time, but that a three year contract should be developed with Portsmouth Council for Community Service, subject to the successful negotiation of a service specification.

6 Equality Impact assessment

A preliminary equalities impact assessment has been carried out on this report, and has been forwarded to the Equality and Diversity Team.

This scheme offers a befriending service to vulnerable housebound or socially isolated older people. It has been very successful and relies on 86 volunteers supporting 200 older people across the City. The main aim of the scheme is to help service users to maintain their dignity and independence. This is a cost effective service that reduces the need for more expensive alternatives. This would otherwise have to be provided by the City Council. **Recommendation: £80,000 (2nd year of 3 year contract)**
