# 4. ... Licensing Committee – Night-time Visits

# 5. Licensing Statistical Bulletin 2008 – Alcohol, Entertainment and Late Night Refreshment

The Department for Culture, Media and Sport ("DCMS") is responsible for compiling a National Statistics bulletin on alcohol, entertainment and late night refreshment under the Licensing Act 2003 ("the Act").

This is in line with the first Licensing Act 2003 data collection exercise which was conducted last year. The information collected from all the licensing authorities in England and Wales will form the basis for future collections and will continue to inform their ongoing monitoring of the licensing regime.

### 6. Recent Prosecutions – Licensing Matters

#### Purpose

The purpose of this report is to advise members of recent prosecutions

instigated by the City Solicitor on behalf of your reporting officer. It is normal policy to provide details of prosecutions to the committee for information purposes. This report follows a previous report submitted to the Licensing Committee on 31 October 2006 (Minute 25/06 refers).

Prosecution files are considered in accordance with the council's adopted enforcement policy concordat and where the city solicitor is satisfied that the offence is serious and it is both in the public interest/appropriate to proceed. This report does not therefore include pending matters under investigation or the issue of simple cautions, suspension of vehicle and driver licenses together with written and verbal warnings issued to licence holders/licensees by your staff.
