VOTER TURNOUT AND DEMOCRATIC ENGAGEMENT

Purpose

- 1. Members have suggested that one of the existing 'medium' priorities for review 'Voter Turnout and Democratic Engagement', should be reclassified as a high priority.
- 2. This report sets out to provide some background information and identify some particular issues that the Panel may like to suggest are addressed during any review.

Recommendations

- (1) That the Policy and Review (Oversight) Panel be asked to re-classify as a 'high priority' a review of voter turnout and democratic engagement
- (2) That the Oversight Panel be asked to refer the proposed review and arrangements for its scoping to an ad hoc panel to undertake at an early date, with a recommendation that -
 - (a) in respect of voter turn out, as part of its work the panel examines recent local voting trends; considers various initiatives that have been proposed nationally to increase the vote at elections, and brings forward for consideration by the City Council recommendations on ways and means of seeking increased voter turnout;
 - (b) in respect of democratic engagement, as part of its work the panel focuses on some of those areas that are not currently the subject of examination elsewhere and that the detail of this part of the review be settled by the ad hoc panel.

Background Generally

3. At the meeting of the Performance Panel held on 28 July 2004 members noted that the topic of voter turnout and democratic engagement had been included as a medium term priority in the policy and review work programme for 2004-05. As some members felt that this review should be given higher priority they requested that a short information report on the matter be produced for this meeting to enable the Panel to consider an appropriate way forward. In-depth pieces of policy review work of this nature would usually be conducted by an ad hoc Policy and Review Panel at the request of the Policy and Review (Oversight) Panel.

Statistical Information

- 4. To assist members in appreciating aspects relating to electoral turnout, the following statistical information covering the period from 2001-2004 is attached as an appendix –
 - Published Electorate, based on the 15 October qualifying date
 - Electoral Register annual preparation Response from households – 'the canvass return' (Number of Houses Responded and % of Houses Responded)
 - Election Turnout (Number of Votes Cast)
 - Postal Votes Issued
 - Postal Votes Returned (Used)
- 5. Figures for 2001 show the pre-boundary changes that increased from 13 to 14 the number of electoral wards. From 2002, Baffins Ward was created and the names of Central Southsea and Eastney & Craneswater were introduced for the previous wards of Havelock and Highland respectively. As part of the changes most ward boundaries throughout the City were altered. The electorate figures are those for the published register of electors based on the annual qualifying date of the preceding of 15 October. The figures do not take account of rolling registration, whereby electors can be added to and removed from the register as they move address (which by itself does not alter significantly the published number).
- 6. The election statistics shown are for the following elections –

2001 General 2002 Local 2003 Local 2004 Combined European & Local.

Electoral Turnout

- 7. Election turnout can be influenced by a range of issues, and these can generally be summarised (in no particular order) as
 - General level of public interest in local and national affairs
 - A current local topic of public interest that has been featured in the media
 - Publicity (both editorial and advertising) in the media about elections generally
 - Calibre and personality of the candidates
 - Political parties canvassing and quality of election literature and manifestos

- Location of polling stations
- Weather on the day
- postal voting arrangements
- 8. The turnout at the 2004 combined elections was an average of 34%; up from 23% in 2003. Within the Council's Corporate Plan increasing the percentage turnout in local elections is one of the targets.
- 9. The Electoral Commission has recently published a report on the outcome of the 'all postal ballots' arrangements during the European Elections. The Commission has recommended that 'all postal pilot schemes' at elections should not continue, and that a new model of voting reform needs to be developed to enhance the degree of choice available to voters.
- 10. If members wish to examine and take evidence upon electoral turnout, they may wish to invite evidence from, for example -
 - Local election agents
 - councillors
 - The public, including community groups
 - The media

In addition, there should also be informed research undertaken, consulting as necessary with other local authorities, on experiences related to an examination of additional forms of voting. This could include, for example, voting using electronic means, giving a choice to voters of where and when they can vote.

Democratic Engagement

- 11. Democratic engagement is a fairly wide term. Members need to be clear as to whether they wish this to relate solely to the election process or, as I believe should be the case, in the more wider context.
- 12. Democratic engagement and community involvement can therefore extend through a whole range of functions and opportunities, including (in no particular order and certainly not an exhaustive list)
 - The role of councillors and how they engage with the public
 - Public participation and consultative arrangements
 - The opportunity for public involvement at Council meetings, the Executive, policy and review panels, and committees
 - E-government initiatives, encouraging people to talk to each other and to the Council about local issues that matter
 - Neighbourhood Forums
 - Southsea Town Council
 - Publicity produced by the Council, including Flagship
 - Public surveys and MORI polls

- Community involvement is one of the priorities within the Community Strategy. In this respect the Strategy identifies that there is a need to –
 - increase grass-roots participation be making sure that there are a range of formal and informal ways for people to make their own contribution to debates on local issues. This will include the continued development of the neighbourhood forums.
 - ensure people know how to make their voices heard. The Portsmouth Council of Community Service will be commissioning research about local engagement with democratic structures.
 - encourage children and young people to have their own say in the community's affairs by developing a range of appropriate forum across the City.
- 14. Increased participation in civic issues is one of the targets that has been identified for incorporation into the initial submission to the Office of the Deputy Prime Minister for the 2nd generation local public service agreement (LPSA2G). Possible measures include the percentage turnout at local elections; attendance at neighbourhood forums and community board meetings, and active involvement in community organisations. This is also one of the targets in the Council's Corporate Plan.
- 15. Before embarking upon a review there will be a need to consider whether to examine this subject in as wide a context as possible or to take a more narrow view, concentrating perhaps on some specific key areas. I suggest that this aspect could be considered by an ad hoc panel as part of the scoping process for a review. It would also be for that panel to decide who should be invited to give evidence.
