### 248 Clerk's Items (AI 7)

The Clerk also advised Members that Mr Roger Young, the Horticultural Consultant, was at present recovering in hospital following illness. Members of the Committee and officers joined in wishing Roger a speedy recovery.

## 249 Annual Statement of Accounts 2007/08 (Al 8)

## (b) Installation of Mercury Abatement Plant

In presenting this report the Engineer and Surveyor noted that the proposed date for completion of the works at Portchester was 2010 and referred to the concern by CAMEO that specialist contractors may not be able to meet the demand from Crematoria within the 2012 timescale set by the Government.

Mention was also made of the expressions of interest that had been received from specialist companies for this work, following advertisement. The Engineer and Surveyor also referred to informal consultation that had taken place with Fareham Borough Council's Planning Department in preparation for the submission of a planning application in respect of the building extension that would be required.

## RESOLVED (1) that the report be noted;

(2) that approval be given for the submission of a planning application for the extension of the crematorium to accommodate the provision of the mercury abatement equipment.
