The Leader of the Council, Councillor Gerald Vernon-Jackson proposed that this item be discussed in open session provided that no members wished to discuss the detail in the exempt appendix and this was agreed. He did not therefore move to go into exempt session. The meeting proceeded on that basis.

A written deputation had been received from Mr Daniel Marshman on behalf of the Pyramids Advisory Group which was circulated to Cabinet.

Councillor Jim Patey made a deputation in favour of option (ii) Close, demolish and landscape the Pyramids site pending consideration of alternative uses of the site.

Councillor Gerald Vernon-Jackson was obliged to leave the meeting at 1.12pm owing to other council business and Councillor Hugh Mason chaired the remainder of the meeting.

### **DECISIONS** that:

- (1) Members noted the comprehensive procurement process that has been undertaken which was designed to encourage bids against as wide a range of options as possible.
- (2) Members noted that the only market interest expressed through the procurement process is to continue to operate the building on a contract for services basis.
- (3) Members considered whether to:
  - i. Let a management contract for the continued operation of the Pyramids to the most advantageous bidder, or
  - ii. Close, demolish and landscape the Pyramids site pending consideration of alternative uses of the site.

and resolved to let a management contract.

(4) Having resolved to let a management contract, Members approved acceptance of Bid B as this represents the most advantageous bid as it represents a saving to the Council over 5 years of £800,000 compared to the approved budget and the bid also received the highest score in terms of quality.
