Minutes of the meeting held on 1 September 2009.

These minutes were agreed at the 24 September 2009 meeting, but the following amendment submitted by Cllr Jensen was not noted, due to an oversight in the preparation of the previous minutes.

Page 22, para 4 read "The Chair noted that Councillor Jensen had intended to write to Colas about the length of time taken to paint the columns but had not done so"

Councillor Jensen had explained to the Panel why he had not sent the letter and has requested that the minutes to be amended to reflect this, as follows:
