2 Purpose

2.1 The purpose of this report is to inform the Cabinet Member of the discussion at Schools Forum on 9 February 2022 regarding the proposed Early Years Block element of the Dedicated Schools Grant (DSG) budget for 2022-23.

3 Recommendations

It is recommended that the Cabinet Member:

3.1 Notes the discussion at Schools Forum and the proposal to amend the Early Year budget by adding 1p to the hourly rate for three and four year olds, and reduce the centrally held contingency by the same amount as set out in Table 1 and Appendix 1.

4 Background

- 4.1 The DSG is a ring-fenced grant for Education and can only be used for the purposes of the Schools Budget as defined in the School and Early Years Finance (England) Regulations. For clarity it does not impact on the Council's budget.
- 4.2 The regulations set out that the DSG budget is approved before the 28 February 2022, to enable schools and early years settings to be notified of their individual budgets by the statutory deadlines. As part of the approval process the budget is taken to Schools Forum to seek their views and endorse the budget proposals before going to the Cabinet Member for approval. At the 9 February Schools Forum meeting a suggested amendment to the proposed funding of Early Years settings

was endorsed and this report sets out the proposals to the Cabinet Member for consideration at the Decision meeting on 16 February 2022.

5 Early Years Block

- 5.1 At the 9 February Schools Forum, Forum members discussed the financial pressures being felt by the Early Years sector in particular the increased costs relating to fuel, the national living wage and increased national insurance payments. The Schools Forum asked if the authority would consider an increase of the hourly rate to Early Years providers of 1p, funded by a reduction in the centrally held growth contingency.
- 5.2 The authority has considered the proposal and financial modelling has confirmed that a decrease in the three and four year old contingency would be a manageable risk considering the DSG carry forward balance.
- 5.3 The table below sets out a proposed revision to the Early Years funding formula for 2022-23. The proposed revision to the Early Years block of the DSG is set out in Appendix 1.

6 Reasons for recommendations

6.1 Due to the timings of the School Forum and Cabinet Member Decision Day meetings, the report had to be published before Schools Forum could discuss the proposals. Whilst the report took into consideration the response to the consultation, discussions at Schools Forum, identified financial concerns on behalf of Early Years providers. Therefore, the recommendation is to increase the hourly rate to providers by 1p per

hour for three to four years olds. This will be funded by a reduction to the three and four year old contingency, which would be a manageable risk considering the DSG balance.
