15 Welcome and Introduction

The chair welcomed everybody to the meeting.

16 Moment for Quiet Reflection

Marilyn Leggett led and explained that this coming weekend sees the 135th Anniversary reunion of Portsmouth Salvation Army Band, this is followed on 1st to 5th July the Salvation Army will be celebrating the 150th anniversary of its commencement in the East End of London with a Congress in the O2 Arena with representatives from 126 countries.

Marilyn continued with the awe-inspiring story of Lieut-Colonel Alida Bosshardt, whose humanitarian work and self-sacrifice throughout the second World War and beyond helped save many lives.

17 Declaration of Interests

No interests were declared.

18 Apologies for Absence

Apologies for absence were received from Geoff Wheeler; Venuka Vyas; Ven. Dr Joanne Grenfell; Richard Wharton; Siôn Reynolds and Sandra Gibb.

19 Minutes of the Previous Meeting held on 11 March 2015

RESOLVED that the minutes of the meeting held on 11 March 2015 be confirmed as a correct record.

20 Matters Arising

(a) Minute No 10 - RE Boxes

Sarah Long reported that the RE boxes had seen regular use and borrowing from schools in the past few months.

Sarah Long also reported that it is expected that the EMAS office will be moving to the Civic Offices in September. It is anticipated that RE boxes may see a greater use because of this, as EMAS will be able to utilise the Council's courier/dispatch service, instead of relying on teachers to collect and return borrowed boxes.

The nominal charge of £1 per box per week is expected to continue to cover basic admin and fund replacement materials as needed.

21 Brief updates or notifications of items to be brought to a future meeting

Beverley Millsom informed SACRE members of the Primary Network meeting taking place next week (23 June) at Redwood Park school. Beverley is expecting 10 teachers to be in attendance and Taki Jaffer and Ruth Guyer both volunteered to take part in a "Q&A" session with regard to the respective faiths.

Elizabeth Jenkerson reported that the Monitoring sub-committee met yesterday and will bring a report to a future meeting.

22 Updates from the Chair

Elizabeth Jenkerson reported on the following items;

(a) SW SACRE

Elizabeth reported on the conference in Somerset with Dr Joyce Miller as main speaker, who is the Chair of the RE Council. The conference proved to be an excellent networking opportunity.

(b) Trojan Horse

Elizabeth reported on the Birmingham Trojan Horse, which has proven to be an interesting learning experience for all those involved in RE. Elizabeth cited Alan Brine (recently retired Ofsted inspector) who raised questions about

ethos of schools designated as a faith school and collective worship.

Elizabeth also mentioned that during the investigation, Ofsted inspectors viewed schools websites, which must include details about teaching of RE. Failure to do so can be considered as a violation of statute. The teaching of RE must include at least 2 religions for GCSE qualification.

(c) NASACRE AGM

As previously circulated to all SACRE members, Elizabeth covered some of the interesting points raised in Charles Clarke's pamphlet.

Particular concern was expressed about the concept of a possible introduction of a National Syllabus, replacing the Locally Agreed Syllabus. SACRE members discussed their concerns about a National Syllabus, arguing that at least in Portsmouth, using the LDR 2011 (having been identified as one of the best) changing would be to our detriment. It was also mentioned that if introduced as part of the National Syllabus, the question of parents being able to withdraw their children from RE which in turn could therefore allow withdrawal from other subjects.

RESOLVED that the updates be noted.

23 Conference Update - 3 September 2015 (AI 9)

Elizabeth Jenkerson informed members of SACRE of the one day conference taking place in September in Winchester. Details of the conference and booking form have been circulated with the agenda.

24 Prevent Agenda (AI10)

Elizabeth Jenkerson welcomed Charlie Pericleous, the prevent co-ordinator for Portsmouth City Council to the meeting.

Charlie gave a presentation that summarised the Prevent Agenda, explaining that it fits into the four Ps that are contained within the Counter-Terrorism and Security Act 2015. Charlie further explained that the Prevent aspect (of the Act) is a duty on all authorities to have "due regard" to prevent all forms of radicalisation. That it is in essence the same as the safeguarding premise, that is to identify, analyse the risks and consider the options, and, importantly, to act and respond before any criminal offence has taken place.

Charlie further explained to SACRE that the definition of extremism feeds into the promotion of British Values and includes all extremist groups that promote hatred and/or violence, not just those of any given faith or belief.

SACRE members sought clarity around whom this Act was focusing on particularly given the previous version of the Prevent Agenda, however Charlie reassured SACRE members that Prevent Strategy clearly addresses all forms of extremism and is consistent with existing safeguarding procedures.

Sarah Sadler expressed on behalf of teachers, their concern about schools and teachers being held to account if they fail to identify individuals at risk.

Charlie reassured SACRE members by highlighting that school/teachers who follow relevant and up-to-date safeguarding procedures will be compliant with the new Prevent Duty. A number of training options are available to schools on the New Prevent Duty.

Charlie gave all members of SACRE an open invitation to contact him should anyone wish to know more on this subject, discuss concerns or have further questions about the prevent agenda in Portsmouth.

Resolved that:

- (1) Charlie be thanked for his presentation and;**
- (2) The information update on the Prevent Agenda be noted and;**
- (3) The presentation be circulated to all members of SACRE.**

25 Youth Voice

Elizabeth Jenkerson reported on the Hampshire initiative to seek the views and recommendations from year 8 and 9 students on the teaching of RE. Whilst limited to Hampshire at this time, the current thinking is Portsmouth may be involved and attend next year, or could set up its own version.

RESOLVED that the update be noted.

26 Report on the South Central HUB meeting

Elizabeth Jenkerson reported that the South Central HUB now includes 14 local authority areas. Other matters raised at the meeting included a future "webinar" and University credits for teachers seeking Master level Degree qualifications.

RESOLVED that the update be noted.

27 Grant Proposals

Elizabeth Jenkerson declared an interest in that she sits on the grant determination panel of Westhill.

Members of SACRE were asked to consider possible projects for which Portsmouth SACRE could bid from Westhill, as they still have unallocated funds this year. Elizabeth Jenkerson confirmed this stating that Westhill's grant application process had been extended to 22 July 2015.

RESOLVED that SACRE members write to the clerk with project ideas, with a view to submitting a grant application before 22 July 2015.

28 Co-opting on to SACRE

Given the freedom of Academies over their curriculum, it was understood that those in Portsmouth are still using LDR 2011 when teaching RE.

There was a general consensus that more schools will become academies in the coming years and SACRE members felt it is important to continue to maintain a good working relationship with academies.

Whilst it was felt that a co-opted academy representative would be beneficial, concern was raised over the fact that there are different groups. It is therefore unclear as to whether a single representative could reflect the views of the academy groups in Portsmouth.

RESOLVED that the teacher representatives will report back to SACRE after informal discussions with academy teachers.

The Clerk advised that this meeting of SACRE is not quorate as no representatives from Groups C or D were present.

As no decisions can therefore be made, the minutes of the previous meeting and all decision items will need to be approved at the next quorate meeting.

30 Welcome and Introduction

The Chair welcomed everybody and thanked Reverend Alice Wood for the use of her Church to hold this meeting.

The Chair welcomed Linda Jacobs, the new Local Authority Professional

Adviser and invited Linda to introduce herself to the Council.

Linda Jacobs thanked the Chair and explained that she was the previous Professional Adviser's line manager and had previously been a teacher representative on Hampshire's SACRE. Further, in her current role for the last two-and-a-half years as Portsmouth City Council's Educational Improvement Officer, Linda has visited most of Portsmouth's Schools. Linda informed the Council that she is also an Ofsted Inspector, although clearly does not inspect any schools in Portsmouth.

31 Moment for Quiet Reflection

Before Reverend Alice Wood led the moment of quiet reflection she explained that she was previously a Head teacher of Leigh Park Primary School.

Reverend Alice Wood read a passage from Chapter 1, Kings, with reference to "A Still Small Voice" which can be interpreted to teach that the powerful and loud is not necessarily the voice that should be listened to.

32 Apologies for absence

Apologies were received from Honorary Alderman Tom Blair; Councillor Neill Young, Maria Cole, Beverley Millsom, Sarah Sadler and Taki Jaffer.

33 Declaration of Interests

Elizabeth Jenkerson declared an interest in that she is on the selection board for Westhill grants.

34 Minutes of the Previous Meeting held on 17 June 2015

Agreed that the minutes of the meeting held on 17 June 2015 are a correct record, which will need to be formally agreed at the next quorate meeting.

35 Matters Arising

(a) Minute No 28 - Co-opting on to SACRE

As there were no teacher representatives present, the Council could not be updated as to whether one or more Academy representatives would wish to be co-opted on to SACRE. The Chair through the Clerk will correspond with SACRE teacher representatives ahead of the next meeting.

Linda Jacobs enquired whether there might be interest from the academies into entering into a "Traded Services" concept with a nominal Service Level Agreement (SLA) being levied.

Although unconfirmed, it is believed that all of Portsmouth Schools, including Academies are still currently using LDR 2011 or the previous version of the locally agreed syllabus. Brian Hay as a Governor at the Charter Academy confirmed that they are following the agreed syllabus LDR 2011.

SACRE members discussed the "pros" and "cons" for all parties with regard

to potential changes to RE, inclusion of Academies, the Locally Agreed Syllabus, a potential national syllabus and collective worship. Members generally agreed that whilst work is taking place at national level on these matters, nothing has been decided for SACRE to respond to at this time.

36 Updates from the Chair

Elizabeth Jenkerson reported on the following items;

(a) Secondary School Conference

Elizabeth reported that the conference was a good opportunity to talk to representatives from different boards.

Along with representatives from other Universities the main speaker was Adam Dinham, Professor of Faith & Public Policy and Director of the Faiths and Civil Society Unit, Goldsmiths, University of London.

(b) South Central Hub

Elizabeth reported that the South Central Hub had not met this term.

However, she asked that any teachers interested in gaining credits towards a Master's degree should contact her directly.

(c) Inter Faith Network

Elizabeth reported that IFN is presently focusing on religious literacy.

(d) Farmington Scholarships

Elizabeth confirmed that Farmington scholarships are well respected and always have money available for training. Information on current opportunity was circulated with the agenda.

(e) Monitoring sub-Committee

Elizabeth reported that Monitoring sub-committee is due to meet soon and commented that more attention should perhaps be given to Primary Schools and 2015 GCSE results are not yet available

Linda Jacobs confirmed that she will provide the results, when available so that the sub-committee may scrutinise the details ahead of a main SACRE meeting. Linda suggested that it may be worth reviewing the RE results with other subjects to allow for context and over a period time - probably for at least a 3 year period.

The updates were noted.

37 Brief updates of notable matters

Ruth Guyer reported on the South East England Faith Forum Conference held on 3 September 2015 which Brian Hay also attended.

The main thread of the conference was the "role of faith in British Schools". Ruth reported that in the morning there was a panel discussion entitled the "Faith perspective". The afternoon comprised of a number of workshops covering; SACRE today; SMSC (Spiritual, Moral, Social and Cultural Development); Prevent Agenda; and Legal guidance.

Elizabeth raised Hampshire's "Youth Voice" and asked whether Portsmouth should attend or run our own. Ruth commented that the challenges of taking children out of school may prohibit Portsmouth being able to take part in Hampshire's. SACRE members present agreed that the idea of doing something to share knowledge and for this to be fed back is desirable but, it is uncertain whether schools could accommodate this.

Ruth commented that she herself is more than happy sharing information in schools and added that she attended St. Paul's (in Paulsgrove) "World Faith Week" before half term.

Linda Jacobs reminded SACRE that the Local Authority presently pays for schools to receive "RE News" which is published termly.

Linda Jacobs commented that in her experience teachers appreciate Networks but careful consideration on the location and timing of these meetings is needed as travelling can be a disincentive.

38 Agreed Syllabus Conference

The minutes of the Agreed Syllabus Conference were noted.

39 Portsmouth SACRE Action Plan

Linda Jacobs presented the action plan. The SACRE members present thanked Linda and offered no further comments on the Action Plan.

The Portsmouth SACRE Action Plan was noted.

40 Annual Report 2014/15

The Annual Report 2014/15 was agreed un-amended which will need to be formally agreed at the next quorate meeting.

41 Collective Worship (Debate item)

Linda Jacobs reminded SACRE that Collective Worship is still a statutory requirement and also comes under Section 48 of the Education Act 2005 for school inspections.

It was noted that the majority of schools comply with this requirement with their schools' assemblies. Linda Jacobs commented that with regards to Collective Worship and furthering Action Plan item 4.2, it might be worth asking schools to provide their views on this matter. Elizabeth Jenkerson added that perhaps SACRE members could offer to go to schools and visit assemblies as part of this information gathering exercise.

Linda Jacobs asked whether SACRE would be minded to offer schools guidance on Collective Worship. It was felt that SACRE would need to understand better the current position before doing so.

Elizabeth informed SACRE that there is a conference due to be held later in the year in Sheffield on the issue of Collective Worship, with the main speaker being Charles Clarke.

RESOLVED that the update be noted.

42 Date and venue of the next meeting

The next scheduled meeting of SACRE is Wednesday 23 March 2016 (venue to be decided) starting at 4:30pm.

The chaired asked whether SACRE members would be minded to move the 15 June 2016 meeting, as she would not be able to make this date.

SUPPORT FOR RELIGIOUS EDUCATION

As schools are aware, the revision of the Agreed Syllabus for RE is currently at the writing stage ... thanks to the schools who have supported their teachers to be part of the process, working alongside teachers and SACRE members from Hampshire, Southampton and the Isle of Wight. The process has been ably led by the proven expertise of Hampshire advisers. Once agreed by SACRE, the syllabus will become statutory for all of Portsmouth's maintained schools (other than those that are part of the Catholic Diocese). Academies may choose to adopt this or any other syllabus. The Local Authority will distribute the syllabus to schools in the first half of the autumn term after it has been agreed.

SACRE has agreed that maintained (non-Catholic) schools are sent the Hampshire News relating to RE, which is issued twice yearly to both primary and secondary schools. We hope this subscription can be continued but we would welcome feedback from schools as to its usefulness. Secondary schools have very recently received the latest version.

We have arranged the following support for the new syllabus going forward into the school year 2016-17.

1. **Briefing for Headteachers** of all Portsmouth maintained schools (primary, secondary and special, [but not Catholic]) and all Academies that plan to adopt the revised syllabus. This will take place on **2nd November 08.30-10.00** at the Inn Lodge, Burrfields Road. The session will be led by Pat Hannam, Hampshire Adviser for RE. (*Please note this session is **NOT** for RE Leaders*). There will be no charge for any school/Academy for this briefing which can be booked through the link - <https://www.enterprisestudy.com/View.aspx?p=109248&c=256171&courseid=256171&zz=35726310>
2. **Training for all RE Leaders** of all Portsmouth maintained schools (primary, secondary and special, [but not Catholic]) and all Academies planning to adopt the revised syllabus. This will take place on **30th November 2016 (all day)** and **31st January 2017 (14.00-16.30)** at the Training and Learning Centre, PAFG. Participants must attend BOTH sessions. The session will be led by Pat Hannam and Justine Ball, Hampshire Advisers for RE. There will be a charge for these sessions, although this is subsidised, and lunch will not be provided (on 30th November). Agenda Item 12

The SACRE Directory

SACRE (the Standing Advisory Council for Religious Education) has the responsibility to advise on matters relating to religious education and collective worship in Portsmouth schools. This directory has been produced in order to support Portsmouth teachers.

Many schools recognise the contribution visits and visitors from faith communities can make to religious education and collective worship. This has been borne out by positive OFSTED reports, which indicate how the quality of teaching and learning has been enhanced through pupils' contact with representatives from faith groups and through visiting places of worship.

This directory has been produced to enable teachers to arrange visits or invite visitors into school from faith communities. It has not been the intention to include all the places of worship or faiths represented in Portsmouth. The list has been compiled through SACRE members in order to represent a variety of denominations within Christianity and each of the major world faiths identified in the Portsmouth agreed syllabus 'Living Difference'. Where a faith group does not have a place of worship within the City of Portsmouth, contacts and addresses of the nearest places of worship have been provided.

A number of schools already have good links with ministers, priests and religious leaders within their locality and pupils frequently visit local Churches or places of worship which may or may not be included in this directory. This, of course, should continue, and we apologise for being unable to include all places of worship which welcome school visits.

The first section in the directory contains a variety of denominations within Christianity. Denominations have been listed in alphabetical order and given the title indicated by the contact representative. The second section includes contacts for other faith communities.

The address/location of each place of worship has been indicated followed by the name, address and telephone number of the representative with whom arrangements should be made. Other useful information about facilities has been included.

Arranging visits

Teachers and pupils should be well prepared before visiting a place of worship. Here are some suggested guidelines:

- the teacher arranging the trip should visit beforehand to establish:
 - the purpose of the visit
 - the available facilities, eg: toilets, somewhere to eat packed lunch
 - any particular dress requirements or code of conduct
 - the itinerary for the visit
 - any fees or gifts expected
 - that pupils will not be compromised in any way, eg: expected to pray or give an offering.
- the teacher/organiser should confirm details in writing and confirm by telephone the day before
- parents should be informed of the aims, activities and cost of the visit
- pupils should be directed to behave respectfully and courteously at all times and follow the dress code and code of conduct required.

Visitors to the school

Visitors can bring RE to life for pupils, so it is worthwhile to try to develop contacts with local religious communities. The local church is the first point of contact, and vicars, curates or ministers are usually delighted to be involved with their local schools. Try to invite a variety of denominations. Members of staff or parents may have contacts with the Catholic Church, Quakers or Salvation Army, for example. Inviting visitors from non-Christian religious groups is not always so easy. There are, however, a number of representatives from the major religions in Hampshire, Portsmouth and Southampton who are willing and able to visit schools and talk to pupils about their beliefs and practices.

Set out below are some tips which may help when planning for visitors in school.

- Ensure that the visitor(s) are recommended by other schools. Some representatives can be very enthusiastic to share their faith but they may not be used to communicating with children. Sometimes talks can be too complicated, or tedious, or the speaker's sense of conviction so strong that pupils may feel coerced or compromised.
- Ensure that your visitor is well briefed. She/he will need to know how many children will be present and their ages, their previous learning about the religion, the focus for the session, what you hope to achieve (the intended learning outcomes), any resources you will have available and the time allocation. It would be inappropriate, for example, to ask a visitor to talk *about Judaism*. More focussed guidance is needed such as *role-play the Passover meal* or *explain the story and celebrations of Hannukah*. This is particularly important to someone who is a stranger to the school, but the same level of guidance is just as vital and much appreciated by regular visitors to school, such as the local vicar or minister.
- Ensure that hospitality is offered (a cup of tea or lunch perhaps), but check for any special dietary requirements (kosher, halal or vegetarian for example). Ensure that travel costs are covered and that maps are provided. Clarify any fees which may be incurred. If this is refused a small gift (a book token or flowers for example) will be appreciated.
- Check that your visitor has all the equipment or resources she/he needs, such as an OHP, a flip chart, a table for papers or artefacts, a projector, etc.
- Many visitors ask pupils if they have any questions. Prepare the pupils beforehand and check the questions in order to weed out the inappropriate ones such as *"What colour socks do you wear?"* or *"How much do you earn?"*
- After the session, a letter or card of thanks is always appreciated, especially if pupils are involved, and maybe some samples of the pupils' follow-up work.
