RESOLVED that the minutes of the meeting held on 22 January 2019 be agreed as a correct record.

12. *** A review of general parking issues in Portsmouth with a view to considering alternative strategies. (AI 4)**
The panel heard a deputation from Jerry Brown read out by Councillor Hugh Mason regarding:
 - Dropped kerbs reducing the number of parking spaces available in the road
 - The need for a survey of MF Residents Parking Zone
 - Allowing residents who live adjacent to an RPZ be allowed to buy permits for that RPZ
 - Commercial vehicles parked in residential streets
 - Reducing hospital traffic by brokering a deal with local taxi companies to transport people at off peak times.
 - Providing NHS services on site at more accessible locations.

RESOLVED that the report be agreed and submitted to the Cabinet with the following amendment to recommendations 9-15:
