1. Apologies for absence

4. Review into Children with Disabilities to focus particularly on out of city placements and the use of Beechside

Members noted that the Scrutiny Management Panel had approved the proposed topic below at its meeting on 28 January 2019 for allocation to the Education, Children & Young People Scrutiny Panel.

Review into Children with Disabilities to focus particularly on out of city placements and the use of Beechside

- <u>Out of city placements</u> how effective are our commissioning arrangements, are we getting the right provision and good value, and are the contributions from education, social care and health appropriate?
- <u>Use of Beechside</u> how responsive is the short breaks respite care provision and how helpful is it to parents of children with disabilities?

Alison Jeffery, Director of Children, Families and Education suggested the review could have a broader scope. She noted there were very few placements outside the city. The panel could perhaps look at how the council considers respite and invite families to have their say on how respite is provided. The way families receive money to purchase placements and packages of care could also be considered.

In response to questions from members, Ms Jeffrey noted the suggestion made at the previous ECYP meeting that the provision of education for disabled children was not so much about school education and special educational needs but rather the provision for children at home. She suggested the review could expand its remit to include health services as children's services and health are becoming more integrated. The panel could hear parents' views on health provision. Other support such as clubs and non-residential support could also be considered.

It was agreed that:

- 1. A scoping document would be drafted by officers and circulated to members.
- 2. The scoping document would be agreed at the next meeting and the review start.

5. Timings of meetings

Members agreed to hold meetings on Mondays and towards the end of the day so as to be more convenient for members with work commitments.

6. Next meeting

The next meeting will be held on Monday 15 July at 4pm.

EDUCATION, CHILDREN AND YOUNG PEOPLE SCRUTINY PANEL DRAFT SCOPING DOCUMENT

A review of support for children with disabilities

1. Background

The topic was agreed by the Scrutiny Management Panel at its meeting on 28 January 2019.

2. Objectives of the review

The review will consider:

- How well the council supports children with disabilities and their families with the provision of community based packages of support to promote their care and wellbeing
- (ii) The appropriateness and effectiveness of arrangements for placing children with disabilities in "out of city" residential provision, including residential care homes with and without education
- (iii) The use of the in-house Beechside care home (Drayton) to provide residential short breaks for disabled children and their families

3. Witnesses

Evidence for the review will be sought from:

- (i) Children, young people and families in receipt of support from the council
- (ii) Social Work Practitioners and Managers who support children and young people with disabilities aged up to 25 (to include Adult Services)
- (iii) The Manager and residential staff at the Beechside short breaks centre
- (iv) Schools attended by children with disabilities in receipt of support from the council; likely to be special schools, in particular Mary Rose and Cliffdale Academies
- (v) Managers of health services provided to children with disabilities
- (vi) Managers of residential schools/care homes (names of schools/care homes to be advised) attended by children with disabilities from Portsmouth
- (vii) Cabinet members for Children & Families and Education

4. Timeline

Monday 15 July

Initial meeting to agree the scoping document, receive first evidence from Director of Children, Families & Education, a senior Children's Social Care social worker and agree evidence gathering programme.

October to December

Couple of meetings to gather evidence - one meeting could perhaps be a site visit and the other to hear from witnesses mentioned in section. Not everyone in section 3 has to come to all meetings.

- Panel members to visit Beechside and perhaps one or two other organisations (schools, care homes, groups) as a joint site visit.
- Hear from witnesses mentioned in section 3.

December to January

Officers write report with recommendations and conclusions.

January to February

Meeting to agree and sign off report (February/early March?).

There may be informal meetings between the formal meetings.
