Public health guidance for staff and the public due to Winter coughs, colds and viruses, including Covid-19

- Following the government announcement 'Living with Covid-19' made on 21 February and the end of universal free testing from 1 April, attendees are no longer required to undertake any asymptomatic/ lateral flow test within 48 hours of the meeting; however, we still encourage attendees to follow the public health precautions we have followed over the last two years to protect themselves and others including vaccination and taking a lateral flow test should they wish.
- We strongly recommend that attendees should be double vaccinated and have received any boosters they are eligible for.

- 1. Purpose of report:** The purpose of this report is to inform SACRE of the findings and discussions that took place during the meeting of the SACRE monitoring sub-group on 19 October 2022.

The group received updates on professional RE education and monitoring the effectiveness of RE and the latest overview of results from the GCSE examination series in 2022. An update on implementation of Living Difference IV, including training in RE was received. Also, an update on progress on updating the Portsmouth SACRE directory of places of worship and visitor publications was considered. It was agreed that Sam Duddles and Justine Ball will discuss expanding the membership of the monitoring group in order to ensure representation from each group.

- 2. Recommendations:**

That SACRE notes the findings of the monitoring group meeting and requests SACRE volunteers to join the Monitoring Group in the Spring term 2023.

- 3. Background:** The monitoring group met at 4.00pm on 19 October 2022.

- 4. Inspector/Adviser Updates:**

- a) Living Difference IV was adopted in November 2021 and schools have now implemented this from September 2022. One of the areas that website monitoring will check is reference to Living Difference IV rather than Living Difference III. Over the period of 2021 to the summer term of 2022, there were three large launch events for the new syllabus and many teachers, leaders and advisers from across Hampshire, Portsmouth, Southampton and the Isle of Wight attended, as these were online. Reference to the syllabus and its requirements is also part of every training offer for RE which Portsmouth schools can attend.



- b) Dates have been agreed for the primary RE networks which will take place once each term online. The numbers for these are usually good. Discussion was held about how to reach RE leaders who do not attend training and possible ways to reach out to them, including RE e news which people can receive free of charge from the Hampshire RE centre.
- c) An update was given about the recent free of charge CPD offer for Portsmouth Primary schools at Portsmouth Anglican Cathedral on diversity in Christian traditions. Three of the monitoring group were present at this and two spoke at it as well as the Inspector/Adviser. Materials from this will be shared on the open access RE Moodle for other teachers to use.
- d) The group discussed monitoring Collective Worship and ways that this could be done, including looking for information on school websites and asking for information in the RE networks.
- e) It was noted that the White Paper will be discussed at the next NASACRE training event to be held on 17 November 2022, 7-8 pm online. SACRE members will be encouraged to attend this and are able to book through the SACRE clerk.

5. Updates on Portsmouth 2022 GCSE Religious Studies examinations and known results:

Since the full set of data is not available currently, a full report on this will be brought to the next meeting of SACRE. However, data available from Ofqual (which includes Southampton and Portsmouth in the Hampshire Data), indicates that these results for the region will have been above the national.

6. Other sources of evidence of effectiveness of RE:

The Inspector/adviser reported that there were very few mentions for RE specifically in the Ofsted reports for Portsmouth. Where RE was mentioned, it was spoken of positively. It was mentioned that Ofsted feedback sessions provide more information than the written reports and that RE is often mentioned as a strength of the school, but that this may well not be included in the final report. It was stated that the Ofsted subject report for RE is due shortly and this will be studied carefully to consider the key findings for the subject.

7. Monitoring school websites:

The Inspector/Adviser reported that she would be meeting with the Head of School Improvement shortly to discuss beginning the monitoring programme. Volunteers to do this from the monitoring group would use a checklist to ensure that they were consistent in looking for information and recording it in the same manner. This would be done and reported on in the next monitoring group meeting.

8. Update on ECT and subject training offer:

There is real concern nationally and locally about recruitment into Secondary initial Teacher education courses, including RE PGCE courses and many institutions are struggling to fill places. It was noted that Winchester University now offers training on Humanities with RE as part of its offer to help recruitment of future teachers. It



was commented upon that if RE is not taught well at GCSE and A level, then students will not go onto study the subject at university. Discussion was held about the change in name from Religious Education to Philosophy, Religion and Ethics in one school. Here, student numbers had significantly increased and students were going on to study the subject at University and the perception of the subject appeared to have improved. Further research was needed on this in other schools to comment on this in more detail.

9. AOB

- a) The Inspector/Adviser talked about the approach to teaching Religious Education in the syllabus and that it was useful to remind SACRE members about this so that their monitoring of the subject could be informed by this approach. This would be discussed at the next SACRE meeting, in particular pages 105-107 in the syllabus.
- b) The chair of SACRE commented that the Portsmouth Places of Worship Directory had been well received by schools. She was updating information in the directory and requested further information from SACRE members on places of worship to add to the directory where there were gaps in information.

3. **Background:** SACRE's membership is comprised of 4 groups; more detail is available in SACRE's constitution:
Group A: Christian denominations and other religions and their denominations, reflecting the principal religious traditions of the area.
Group B: The Church of England with representatives nominated by the diocese.
Group C: Teacher and Head teacher representation.
Group D: The Local Authority: appointed by the Local Authority.

Each group has one vote in the case of a voting matter. In addition, SACRE can co-opt members, who do not have voting rights.

SACRE continues to seek a representative from Portsmouth Catholic Diocesan Office and also seeks Buddhist and Hindu representatives for Group A.

SACRE is seeking an additional CofE representative for Group B and one additional teacher representatives for Group C (Early Years).

SACRE is continuing to develop its collaborative work between the Council for Portsmouth Student (CoPS) and SACRE.

CHAIR'S INTRODUCTION

I would like to begin my introduction by offering sincere thanks to all members of Portsmouth SACRE, and many others including teachers and community members, who have work so hard to support RE in Portsmouth in the year covered by this report. We must acknowledge also that the year 2021/22 has been another extraordinary year in light of COVID-19. I would also like to thank members of SACRE for their willingness to embrace the technology necessary to meet 'virtually' and to show such enthusiasm for training events and conferences that have been made available through our membership of national organisations. Continuing Profession Development Training has continued to be offered to primary and secondary teachers through our links with Hampshire inspectors/ advisers. SACRE receives professional advice from Patricia Hannam and Justine Ball, who as primary inspector/adviser in Hampshire has also maintained contact with primary schools where possible during this period.

In November 2021 the Portsmouth SACRE agreed a new local syllabus, Living Difference IV, and were delighted to welcome over 350 schools from across the wider region to conferences to launch the syllabus to our schools. In addition, Debbie Anderson, Head of School Improvement in Portsmouth, launched Living Difference to governors in the city.

SACRE has continued with its monitoring responsibilities and has much planned to support the implementation of the new agreed syllabus Living Difference IV. This year there has been a particular focus on compiling the Places of Worship directory for RE teachers across the city, the form to support the planning of visits the Golden Threads within the agreed syllabus Living Difference IV.

SACRE continues to ensure members are able to participate in regional and national RE meetings and events. In the period of this report, this has included attending the virtual South West AREIAC SACRE conference, NASACRE AGM as well as the regional South Central SACRE Hub meetings. SACRE continues to follow with interest developments following the publishing of the report from the Commission on RE (CoRE) in 2018. SACRE places the concern to ensure all children in Portsmouth have access to high quality and challenging Religious Education at the heart of all its work. SACRE is grateful also for the opportunities our partnership with Hampshire, Southampton, and the Isle of Wight continues to offer teachers and our children and young people alike. In addition, the SACRE has embarked on an exciting collaboration with the Council for Portsmouth Students (CoPS) and will be continuing to develop these links to ensure that the student voice on RE and collective worship in primary and secondary schools across the city.

This year we have said farewell to Patricia Hannam as Hampshire advisor to Portsmouth SACRE and have thanked her for her dedicated service to SACRE and over five years of professional advice and support which have been highly valued by us all. SACRE continues to receive excellent clerking support from within the Authority and valued working with Lisa Gallagher and Karen Martin.

SECTION 1: INFORMATION ABOUT SACRE

1.1 Duty to establish a SACRE

Since the Education Reform Act of 1988, all Local Education Authorities (LAs) have been required by law to constitute a Standing Advisory Council for Religious Education (SACRE) within their local area.¹

1.2 What does a SACRE do?

SACRE is a unique body; it is set up by the LA but is independent of it, with the role to give advice to that LA. The law states that Religious Education must be taught in all maintained schools² and a SACRE's role is to advise what needs to be done to improve religious education (RE) and collective worship for schools in its area.

The main purpose of the annual report is to hold the LA to account, by informing the Secretary of State and key partners what advice SACRE gave the LA during the year and how the LA responded to that advice. This includes advice on Religious Education and Collective Worship in those schools for which the LA has responsibility.

1.3 Composition of SACRE

There are four groups or committees, as below:

- A: The Christian denominations and other religious denominations, reflecting the principal religious traditions of the area.
- B: The Church of England
- C: Teacher and head teacher associations
- D: The Local Authority

The Local Authority has determined that the SACRE should comprise of:

- Representatives of Christian denominations and other religious groups reflecting the principal religious traditions of the area
- Four representatives of the Church of England.
- Six representatives of teachers' associations.
- Four representatives of the local authority, at least two of whom should be elected members.

Other members may be co-opted from time to time as appropriate for all or part meetings

1.4 Membership of SACRE

The names of the SACRE members and the religious denominations for Group A can be found at Appendix A.

1.5 SACRE Functions

- To advise the LA on collective worship and the Religious Education to be given in accordance with the agreed syllabus including methods of teaching, advice on materials and the provision of training for teachers
- To consider whether to recommend to the LA that its current agreed syllabus should be reviewed by convening an Agreed Syllabus Conference.
- To consider whether the requirement that religious worship in a county school should be 'broadly Christian in nature' should be varied (determinations).
- To report to the LA and the Department for Education (DfE) on its activities on an annual basis.

SACRE met on three occasions during the academic year 2021-22 - including a meeting to consider the adoption of a revised agreed syllabus for religious education in Portsmouth

SECTION 2: SUMMARY OF SACRE'S WORK in 2021/22

2.1 Agreed Syllabus adoption and implementation

- A significant part of SACRE's work in this period following the adoption of Living Difference IV in November 2021 has been ensuring information reaches all schools facilitating its implementation.
- In light of continuing concerns regarding COVID-19, apart from the ASC in November 2021 to adopt Living Difference IV and the immediately following SACRE, all meetings in this reporting period have taken place virtually. *Living Difference IV* was adopted by the Agreed Syllabus Conference in November 2021. This syllabus is shared by Portsmouth, Hampshire, Southampton and Isle of Wight local authorities.
- SACRE together with the Local Authority has continued to support the implementation as indicated through the activities discussed below from 2.2 – 2.5.

2.2 Meeting Training Needs

- The duty on schools regarding religious education is raised regularly at head teachers' meetings and in other ways through SACRE's strong links with the authority's school improvement service and Director of Education. Many schools in Portsmouth are now Academies. Although these schools are not obliged to follow the Agreed Syllabus, SACRE is keen for all schools in the Authority to use the syllabus. This is to ensure consistency of experience in religious education for all children across the Authority, regardless of where they go to school. SACRE is keen to impress on Academies, that it is vital schools use Living Difference IV with integrity. Primary network meetings continue to be held. Secondary RE Subject leaders are encouraged to attend Hampshire Secondary RE Networks that can be booked through the Hampshire Learning Zone platform. Teachers from Portsmouth participated in review and revision meetings.

2.3 Resourcing Living Difference IV

- Primary RE Curriculum Update publication, produced by Hampshire Inspectors, is available for Portsmouth schools to subscribe to. Teachers are also aware of

the other published resources available to support the teaching of Living Difference IV through the Hampshire RE Centre in Winchester. Materials on the Hampshire RE Website are also available to Portsmouth schools as a subscription service. There are other materials available openly on the Hampshire RE Moodle.

- SACRE's artefact loan collection continues to be available to schools and is maintained by the Ethnic Minority Achievement Service (EMAS) and the Authority's despatch team deliver/collect boxes without charge. However, during the period of this report, in light of Covid-19 there have been some changes to this service.

2.4 Monitoring the effectiveness of the Agreed Syllabus

- A representative monitoring group has met virtually during this reporting period. It meets at a suitable time before each full SACRE to monitor the effectiveness of the Agreed Syllabus. The group is comprised of at least one representative of each of the 4 SACRE groups, including the Chair. Materials used to judge effectiveness include Ofsted reports from Portsmouth schools, together with other data such as KS4 GCSE results. During the period of this report, for a second year no subject level data has been available for consideration due to the impact of COVID-19. SACRE is also mindful that Ofsted reports are aimed at parents and rarely mention religious education.
- An innovation during this reporting period, has been establishing criteria to assist schools in ensuring their websites accurately represent what is taking place for religious education. Subsequent reports will include analysis of information gathered from the examination of schools' websites.

2.5 Maintaining SACRE Effectiveness

- SACRE has met three times during this period. One meeting was held in person in the Guildhall and two have been held virtually.
- SACRE seeks to ensure that all four groups are well represented at all meetings. Although new representatives in some groups have been made recruitment from some faith groups in Portsmouth continue to be challenging.
- Teacher representatives from primary schools, secondary schools as well as post-16 providers have attended SACRE during this period.
- Two virtual launch conferences have taken place for Living difference IV during this period and SACRE were encouraged to attend.
- Reports have been regularly presented to SACRE to ensure that SACRE is well informed about local and national matters in relation to religious education.
- Where members have been able to attend local, regional or national events held virtually during this period, this has been facilitated, for example the South west AREIAC conference in March 2022, NASACRE AGM in May 2022 and termly (virtual) South Central SACRE Hub meetings.
- A pre-SACRE meeting with the Chair or Vice Chair, SACRE Clerk and SACRE Professional Adviser has taken place prior to SACRE meetings during this period.

2.6 Website Advice to Schools

- Advice has been developed and shared with schools regarding what should be mentioned for Religious Education on their website.

2.7 Advice regarding visits to Portsmouth places of worship

- SACRE has worked together during this period to update and republish online its advice to schools regarding visiting local places of worship. This is now available to all schools and forms an important part of community building across the authority.

SECTION 3: STANDARDS IN RELIGIOUS EDUCATION

3.1 Commentary on GCSE examination results in Religious Studies

Background information

- GCSE Examinations in 2021 should have been the fourth year of the RS GCSE specification first available for examination in the summer of 2018.
- Since 2018 GCSE grades are awarded in the form of 9 (highest) to 1 (lowest); grade 4 regarded as a 'standard pass' and grade 5 as a 'good pass'.
- The GCSE RS full course is intended to be taught over 2 years, sat at the end of year 11 and to be taught in 120 hours of teaching time.
- RS GCSE tests not only knowledge but the capacity to *analyse* and *to use evidence and logical chains of reasoned argument to evaluate*. Teaching must enable students to do this as well as remember subject knowledge. RS GCSE success has a high demand in terms thinking as well as writing. Where young people are given the opportunity to analyse, evaluate and in other ways reason well at KS3 standards are higher at GCSE.

3.2 GCSE Religious Studies examination results 2021: overall findings

- In the summers of both 2020 and 2021 GCSE examinations were suspended and grades awarded to students on the basis of teacher assessments. No verified school level data has been available to local authorities in 2021.
- SACRE remains concerned about the low numbers of young people in Portsmouth who are entered for the full course RS GCSE and therefore concerned to ensure through all means possible that in other ways young people are able to access their entitlement for religious education at Key Stage 4.

3.3 Quality of Teaching and Leadership in Religious Education

- During Covid-19 and the period of this report, SACRE has continued to fulfil its duty to monitoring the effectiveness of the Agreed Syllabus in a number of ways. An innovation in 2021/22 has been establishing criteria for what should be

included on a school website. This has been communicated to schools through the School Improvement Service.

SECTION 4: COMPLAINTS ABOUT RELIGIOUS EDUCATION

SACRE has received no formal complaints about religious education in the past year.

SECTION 5: COLLECTIVE WORSHIP

5.1 Monitoring Collective Worship

- Ofsted reports sometime mention collective worship in relation to evidencing that a school is promoting children's SMSC development and personal wellbeing.

5.2 Complaints

- There have been no complaints about Collective Worship in schools.

5.3 Determinations

- Determinations procedure was agreed in 2021. No requests for determination have been received by SACRE during this period.

SECTION 6: LINKS WITH OTHER BODIES

6.1 Links with other Authorities and SACREs

- Portsmouth has links with Hampshire SACRE through members on both bodies. Portsmouth SACRE also takes an active part in South Central SACRE Hub meetings.

6.2 NASACRE

- Portsmouth SACRE is a member of NASACRE, subscribes to the NASACRE training and SACRE members attend its training courses. NASACRE bulletins are regularly circulated to all SACRE members by the Clerk. SACRE members attend conference and AGM.

6.3 South Central RE/SACRE Hub

- Portsmouth SACRE members are invited to the South-Central Hub meetings during the period of this report. During the period of this report the SACRE hub meeting was held virtually, and this has enabled SACRE members to attend more frequently.
