Public health guidance for staff and the public due to Winter coughs, colds and viruses, including Covid-19

- Following the government announcement 'Living with Covid-19' made on 21 February and the end of universal free testing from 1 April, attendees are no longer required to undertake any asymptomatic/ lateral flow test within 48 hours of the meeting; however, we still encourage attendees to follow the public health precautions we have followed over the last two years to protect themselves and others including vaccination and taking a lateral flow test should they wish.
- We strongly recommend that attendees should be double vaccinated and have received any boosters they are eligible for.
- If unwell we encourage you not to attend the meeting but to stay at home. Updated government guidance from 1 April advises people with a respiratory infection, a high temperature and who feel unwell, to stay at home and avoid contact with other people, until they feel well enough to resume normal activities and they no longer have a high temperature. #### 1. Purpose of report

1.1 The purpose of this report is to set out the next steps for the emerging Portsmouth Local Plan and to seek your opinion on how you and other Councillors would like to be engaged in its formulation. The report also sets out changes to legislation and national planning policies that affect the Local Plan and the main risks to the project.

#### 2. Recommendations

- 2.1 To approve the upcoming schedule of Member workshops on the Local Plan and decide who will attend them.
- 2.2 To note emerging changes to legislation and national planning policies that affect the Local Plan and the main risks to the project.

#### 3. Background

3.1 This report follows on from an email sent to members on 07 December 2021, asking their opinion on the next steps for the Local Plan. No responses were received.

#### 4. Reasons for recommendations

4.1 We consulted on the draft Local Plan in Autumn last year and we presented a progression update to Cabinet in March this year along with a <u>consultation</u> <u>summary report</u>. The report sets out the number of responses to each question in the Local Plan, a brief summary of the main points made and the City Council's response. Each policy was then given a RAG rating of Red, Amber of Green. We are in a good position with the Local Plan going forward with most of our policies rated green and so only requiring minor updates. It is the policies with an amber



status that we think need a strategic steer from Members. Table 1 is the summary RAG table.

**4.2** Our suggestion is that we run a number of Member workshops that focus on the amber policies. The purpose of the workshops is to get a strategic steer from Members on these policies, which officers will then action. It is necessary to decide which Members should attend the workshops to ensure cross party engagement. We suggest that ward Members are invited to the site-specific discussions and that relevant portfolio holders and their opposition spokespeople are invited to specific workshops on their subject areas. Furthermore, it is necessary to decide whether we would want to invite external groups to any of these discussions, for example, we could invite the Portsmouth Landlords Association to our discussion on HMOs and site promoters to our site specific discussions. Table 2 sets out the proposed schedule of workshops along with named Councillors and external groups to attend. In order to progress the Local Plan in a timely fashion, the workshops will start at the beginning of February.

- 4.3 The Local Development Scheme (LDS) sets out the timetable for the preparation of the Portsmouth Local Plan and other development plan documents. The latest version of the LDS was approved at Planning Committee on 27 July 2022. The timetable was delayed due to the large number of responses received during the Regulation 18 consultation held in 2021 particularly in regard to the strategic site of Tipner and the desire of the Council to revisit that site and the associated implications for the wider spatial strategy of the City. There have also been further delays due to staff changes. Now that the new Head of Planning Policy is in post, work is underway on a comprehensive new project plan for the Local Plan. An updated LDS will be presented to Members in early 2023. The broad intention is to proceed to the pre-submission consultation by the end of 2023. Before we reach pre-submission we will need to update some of our evidence based studies and refine the draft policies to address matters raised in the earlier consultations.
- 4.4 The main risk to the Local Plan is changes in national legislation and planning policies. The Levelling Up & Regeneration Bill was published in May 2021 and is progressing through parliament. There continues to be heated debate on housing numbers. Draft changes to the National Planning Policy Framework (NPPF) were published for consultation just before Christmas 2022 and included the Government's initial thinking on National Development Management Policies. Under the consultation on the revised NPPF it states that the proposed reformed planmaking system is intended to be introduced in late 2024. It is proposed that LPAs



have until 30 June 2025 to submit a local plan for independent examination under the current legislation. All independent examination of local plans under the current legislation must be concluded with plans adopted by 31 December 2026. Under the proposed reforms LPAs will be required to start work on new plans five years after adoption of the previous plan and to adopt the new plan within 30 months. It is clear therefore that the main risk to plan making for the City Council is to delay the preparation of the new Local Plan and thus have to produce the Local Plan under the new system.

- 4.6 It is of interest to note the following sentence of the consultation: 'the Bill retains considerable scope for local planning authorities to produce their own local plan policies on distinctly local issues.' It then cites the example of where a local plan policy could be developed as 'a university city in which student housing has had a significant impact on the wider housing market,' which is clearly a matter applicable to Portsmouth.
- 4.6 The other main risk is difficulties in recruiting to vacant posts and retaining officers in the Planning Policy team. We are working closely with the HR team on successful recruitment campaign in the New Year for both Policy and DM.

#### 5. Equality impact assessment

5.1 An equality impact assessment is not required as the recommendations do not have a disproportionate negative impact on any of the specific protected characteristics as described in the Equality Act 2010.

#### 6. Legal implications

- 6.1 Estimated timeline for transitioning to the reformed plan-making system:
  - 11 May 2022, Levelling Up and Regeneration Bill was introduced.
  - Spring 2023, Subject to Parliamentary approval, Levelling Up and Regeneration Bill receives Royal Assent.
  - November 2024, Expected earliest date when LPAs with a plan which is more than 5 years old must begin new plan-making process.
  - 30 June 2025, Cut-off date for old-style plans to be submitted for examination.
  - October 2026, Earliest date that the first new-style examinations commence.
  - 31 December 2026, Latest date for any old-style local and minerals and waste plans to be adopted (or in the case of Strategic Development Strategies, published).
  - April 2027, First new-style plans are adopted.
  - 31 December 2031, Latest date when LPAs must begin the new style planmaking process (if their previous plan was adopted on 31 December 2026).

#### 7. Director of Finance's comments

7.1 There are no direct financial implications as result of approving the recommendations within this report.



7.2 The final production of the Local Plan will be met from the existing cash limited budget.
