<b>1</b>	<b>Paulsgrove</b>	<p><b>New Traffic Regulation Order - The Portsmouth City Council (Southampton Road Slipway Car Park) (Off-Street Parking Places) (No.7) Order 2013</b></p> <p><b>Proposal:</b> to advertise a traffic regulation order relating to parking restrictions in the car park area leading to the slipway; access is from the south side of Southampton Road opposite nos. 170-172.</p> <p><b>Council's reasons for the Order</b></p> <p>To introduce a restriction on the time permitted to park in the slipway car park accessed from the south side of Southampton Road, so that it may be used for short-term parking and access to the waterfront.
