The objections relate to the inappropriate nature of the use within a residential neighbourhood and the level of neighbourhood notification. This Portsmouth City Council application seeks permission to use the premises as a supported care home where a small degree of care is provided to future occupants. The property currently is a 5-bedroom house. The submitted plans show that the floorspace would be slightly altered to create a 4-bedroom house. It is considered that the level of activity associated with the proposed use would not be significantly different to the occupation of the property as typical family dwellinghouse. Whilst the exact nature of the proposed use by Portsmouth City Council is known, it is accepted that some alternative more intensive uses that fall within the C2 Use Class could impact upon the residential amenity of adjoining occupiers. In order to avoid the harm that could be caused by a change to another use within Class C2, a condition restricting the planning permission to Portsmouth City Council (or Portsmouth City Council jointly with another body) is proposed.
