Previous priorities that are not getting better

- Healthy life expectancy at birth (males): significantly worse than England, declined for last five years (stable nationally)
- Obese and Overweight at Reception: significantly worse than England, getting worse locally (and getting better nationally for yr 6), and worst of our comparator group
- Persistent absence at secondary school: worsening and worst of our comparator group. Primary persistent absentees also worsening.




2019 Index of Multiple Deprivation:

Portsmouth's rank against upper tier local authorities 2010-2019





Attendance - Secondary School Absence

Good attendance at schools is associated with a range of good child outcomes including of course, educational attainment. There is also evidence of a strong relationship between educational inclusion and child mental health. Children with very low school attendance are also at greater risk of harm, exploitation and youth offending.



Children Killed or Seriously Injured on roads – 11th worst in England


Air Pollution (fine particulate matter, PM2.5) – worst outside London. But below required level, and will be impacted by city's efforts to reduce air pollution from road sources (nitrogen dioxide)



Index of Multiple Deprivation (IMD) 2019 Outdoor Living Environment

- Sub-domain of IMD 2019 focussing on air quality and Road Traffic Accidents
- 6/10 neighbourhoods are in the most deprived 10% nationally.
 - 124/125 are in most deprived 30%

- Under-75 mortality rate from injuries (females) (Mortality Profiles) - 3rd worst in England
- Under-75 mortality rate from cancer (males) (Mortality Profiles) - 12th worst in England
