There is an existing capital allocation within the 2020/21 capital programme that is for feasibility work of a new swimming pool at Eastney to replace the existing 106 year old one which has reached its end of life. In light of structural surveys at Eastney Swimming Pool and Wimbledon Park Sports Centre which reveal that around £2m will be needed to keep the centres open, there is an opportunity to use this

money instead to look for wider solutions to keeping swimming and 'dry-side' sports facilities in the south east of the city, including ones which leverage Sport England funding to invest in the sports and leisure facilities in Portsmouth.

Has any consultation been undertaken for this proposal? What were the outcomes of the consultations? Has anything changed because of the consultation? Did this inform your proposal?

We have consulted with the council's leisure centre operator BH Live; University of Portsmouth sport and recreation service; specialist leisure consultant Strategic Leisure Ltd; Sport England; Portsmouth Northsea Swimming Club.

All are broadly in support of the proposal which aims to take a more strategic look at the provision of swimming (and dry-side offers) in the south of the city.

The provision of a new leisure centre in the south east of the city (one of the options in this report, and the most ambitious one) has the potential to bring a new lease of life to wherever it ends up being built. There is the opportunity to incorporate some community spaces along with the sports and leisure offer which has the potential to give young people more to do, and also to bring people into the new space which will help the self-policing that busy footfall provides spaces.

There are strong links between levels of physical activity and health benefits. Access to quality facilities is key in attracting people to take part. Portsmouth lags behind regional and national averages in terms of physical activity and is above regional and national averages for obesity, especially in children.

The ultimate focus of this report will be the improvement in the quality of sports and leisure infrastructure, and this is likely to translate to improved physical and mental health.

How are you going to measure/check the impact of your proposal?

We are able to record all visitors to our leisure centres using BH Live's managament systems. It will be reasonably easy to see if the ultimate solution results in greater participation levels. The key outcomes (ie levels of obesity, other public health measures will be harder to isolate among the wider factors at play).

We know that one of the barriers to people accessing sports and leisure activities is price. Portsmouth has, for example, sufficient swimming pool provision, but accessibility is an issue because much of the swimming pool area is in private sector establishments the people are pooled to people and lower incomes.

We do not currently record socio-economic data of our customers, but this may be something we could do in future. Whilst this may be possible with members, it will not be easy with casual users of our centres.

Please expand on the impact your policy/proposal will have, and how you propose to mitigate any negative impacts?

As this project is ultimately looking to renovate or replace two old buildings there is scope to improve access to people with physical disability. At the moment Eastney Swimming Pool has serious deficiencies in terms of access for people with reduced mobility. Some of the options being considered are new builds, and so these would be expected to be designed with modern levels of disabled access and changing facilities.

Eastney Swimming Pool is very popular with older people. 15% of tickets are senior ones (compared with 1.6% at our other pools). The continued provision of swimming in the south east of the city will benefit this older demographic.

One of the limitations of the gym at Wimbledon Park Sports Centre is that there is very little scope for group indoor exercise. Any new or combined facility has the scope to include studio spaces to enable greater group exercise participation. Sport England 'This Girl Can' programme has identified that access to group exercise is important in encouraging women to participate in physical activity so this is likely to bring benefits to female levels of exercise.

How are you going to measure/check the impact of your proposal? We are able to monitor sales of senior tickets, and participation (and membership) of gym users based on sex.

Old facilities are less efficient. Eastney Pool is 106 years old and Wimbledon Park Sports Centre is 32 years old. Both have high running costs. One option is to combine the two buildings into one. This option would bring economies of scale in terms of energy usage.  As a new building in the public realm, there would be scope to include photo-voltaic panels to further reduce energy usage.  We are investigating Passiv Haus design principals which at other leisure centres have led to carbon neutral buildings.  One of the issues affecting the current facilities is access. Eastney Pool for example is not served by public transport, meaning that some users will drive instead. Greater accessibility should result in fewer motor vehicle journeys.  How are you going to measure/check the impact of your proposal?  We will be able to compare carbon footprint from energy consumption in the existing facilities with the eventual solution.
