FIFTH AND SIXTH AVENUES'PARKING SCHEME

Thank you for your letter of 4 November 2013 enclosing a petition asking to set up a residents parking scheme.

The parking scheme proposed n 2011 for your area received strong objection from residents and therefore was not implemented. The full report can be found on our website here http://www.portsmouth.gov.uk/media/tt20110728r5.pdf Section 4 is reproduced overleaf and details the response to the public consultation, which led to the recommendation not to introduce the scheme. Implementing part of the scheme only would have moved the vehicles to the wider area, into roads where residents made it clear a parking scheme was not welcome.

4. Reasons for recommendations

- 4.1.1 The combined results of the initial survey and the formal consultation show 226 in favour of a residents' parking scheme being introduced 727 in opposition of a residents' parking scheme being introduced
- 4.1.2 The results of the initial survey are:
 - . 33% (389) of the 1193 forms sent out were completed and returned

Of those who responded:

- 50% (193) showed support for a parking scheme
- 44% (171) felt a parking scheme would not help
- 6% (19) were undecided
- 1% (6) did not indicate an opinion
- 4.1.3 The results of the formal public consultation are:

17 signatures on petitions

OBJECTION
41 letters / emails
515 signatures on petitions
(Total 555)

4.2 The area termed as "Medina Road area" consists of a finite number of 28 streets, primarily residential, with one access in and out (Medina Road). Within this area, 4 of the streets have a significant parking problem according to residents of those roads.

Taking out these 4 streets (Ashurst Rd, Sixth Ave, Herne Rd and Halstead Rd) from the survey data gives the opposite results:

43% (139 / 321) showed support for a scheme 50% (159 / 321) felt a scheme would not help 6% (18 / 321) were undecided 1% (5) did not indicate an opinion

- 4.3 Geographically, Ashurst Road, Sixth Avenue, Herne Road and Halstead Road are at the northern end of this area: the closest to the Queen Alexandra Hospital.
- 4.4 Implementing a scheme in these roads alone would simply push the problem into the surrounding roads, where it is clear there are currently few parking problems. The balance of residents in favour and those against is heavily weighted against a scheme being introduced.

Further to this, the approved 2013-2015 Residents' Parking Programme is currently on hold due to funding and resources constraints. However, your petition will be

considered at such time when the approved Programme can be completed and new areas accessed.
