			Officers concur that the proposal would be too close and dominating to the property to the rear (west), causing a loss of outlook and loss of privacy. This view concurs with many of the matters raised by objecting residents and is contrary to the support letter. Otherwise, the Local Highways Authority raises no objection. The loss of a (relatively small) street tree would be addressed as part of the Highways consent for a new access point, in the event of planning consent being granted. Drainage matters would also be addressed by condition/Building Regulations/Southern Water in the event of consent being granted.

The planning history for the site demonstrates that the property benefits from flexible lawful use as either a Class C3 (dwellinghouse) or Class C4 (house in multiple occupation) (HMO) for a period of 10 years, starting from 28th March 2018.
