1	Central Southsea	The Portsmouth City Council (Albert Road) (No.88) Experimental Traffic Regulation Order 2022	Kevin McKee 07585 987234 (Parking Manager)	<ul> <li>The proposal seeks to restrict parking in one parking space in Albert Road to introduce a parklet.</li> <li>The parklet for this proposal, will provide outside seating for businesses, ample (and safe) bike storage racks, provide benches for walkers of all abilities to rest, ensure sufficient wheelchair, wheeler and walker access, and create microhabitats for foliage, bugs and other local wildlife.</li> <li>To facilitate this proposal, the footway and no waiting at any time restrictions will be extended across part of the Limited Waiting Bays.</li> <li>During the experiment, the parklet and its effect on the community and local network will be monitored.</li> <li>In making any traffic regulation order, the Council must comply with the procedures set out in the Act and the regulations made there under. This procedure for experimental traffic orders requires the Council to publish a notice to the effect that an experimental order has been made and providing that within a period of 6 months, any person may object to the making of the order on an indefinite (permanent) basis.</li> </ul>	To undertake a minimum of 6 months statutory consultation on the proposals. The responses to the consultation will help to determine whether to make the scheme permanent. All responses which cannot be resolved will be discussed at T&T.

The costs associated with a traffic regulation order are substantive and proposing a Traffic Regulation Order (TRO) for each individual site would not be economical. Instead, a few minor amendment requests are grouped together to make up a TRO. These Order types are often proposed bi-annually. The following sites are proposed for the first half of 2022;	To undertake a statutory 21-day consultation on the proposals. The response to the consultation will help to determine whether to implement the proposals or consider alternatives. In the event no objections are received, the scheme will proceed to implementation, as advertised. Otherwise, the responses, if unresolved, will be considered at T&T.

Bourne Road	Paulsgrove Enterprise Centre has been raised by the public and officers expressing their frustration of vehicles parking across accesses and units.	Extend the no waiting at any time restrictions and amend the existing limited waiting bays from 1 hour to 2 hours to mitigate the loss of on-street parking
Fawcett Road	A road safety audit highlight vehicles were parking across a dropped kerb used by pedestrians for crossing, reducing their visibility.	Extend the no waiting at any time restrictions
Green Lane	Vehicles are continually parking across an access road leading to 20 garages, multiple complaints have been received in regards to this matter	Extend the no waiting at any time restrictions

Crofton Road (North End)	Parents outside College Park Infant School have expressed their concerns to vehicles parking on the footway outside of the school, forcing pedestrians into the carriageway.	Extend the no waiting at any time restrictions across both buildouts adjacent to the school
Moorings Way	Motor vehicles have been observed parking across an access/exit to a cycle track and pedestrian crossing. Pedestrians and cyclists are often forced out into the carriageway to see past these vehicles leading to concerns for safety.	Extend the no waiting at any time restrictions across the cycle track, and introduce no waiting at any time restrictions opposite the cycle track
Fratton Road	Outside 45 Fratton Road there is a dropped kerb with entrance line which was for a motorbike shop but the motorbike shop has been gone long time ago. The site is now an Indian Restaurant without any entrance for vehicle access.	Extend the P&D parking outside of Royal Palki
Cosham Park Avenue	Civil Enforcement Officers have visited this site on numerous occasions due to frequent complaints of vehicles parking near or on the turning head, causing obstruction and preventing access to the pharmacy and surgery.	Introduce No Loading across the turning head
Cranborne Road	A property has recently had their kerb dropped to allow off-street parking. A permit parking bay extends across the kerb and vehicles can often obstruct access and egress from the property	Remove the permit parking outside of property 22 and 24
Frensham Road	The use of rental e-scooter parking, operated by the company Voi as part of a scheme to provide e-scooters for hire by members of the public	E-scooter parking in the northern closed end
Francis Avenue	The use of rental e-scooter parking, operated by the company Voi as part of a scheme to provide e-scooters for hire by members of the public	E-scooter parking opposite Orchard Road
New Road	The use of rental e-scooter parking, operated by the company Voi as part of a scheme to provide e-scooters for hire by members of the public	E-scooter parking outside of the Cooperative
