1	All	<p>Education capital programme</p> <p>Approval is sought to spend the £100,000 allocated for Inclusion Capital Grants in 2022 to 2023 from the Education capital programme approved by Full Council on 15th February 2022.</p> <p>The Education Capital Programme approved by Full Council on 15th February 2022 includes £7.9million for Accommodation for Special Educational Needs (additional School Places). £50,000 of this funding has been allocated to provide Inclusion Capital Grants of up to £10,000 to Portsmouth mainstream schools and academies in the 2022 to 2023 financial year. 4		<p>Have your say on planned expansion to shared home licensing</p> <p>Ten weeks of consultation has begun on the proposed expansion of mandatory licensing for shared homes in Portsmouth.</p> <p>The council is considering bringing all houses in multiple occupation with three or four tenants under the same regulations as those with five or more.</p> <p>The consultation is open for comments until 31 July and views are sought from landlords, tenants and residents living near HMOs.
