#### Introduction

#### Governors Handbook – May 2014 states;

c. Overseeing the financial performance of the school and making sure its money is well spent.

## The School Governance (Roles, Procedures and Allowances) (England) Regulations 2013 state;

(c) ensuring the sound, proper and effective use of the school's financial resources.

# The School Information (England) (Amendment) Regulations 2012 – Schedule 4 – Regulation 10 (9) states;

(information to be published on a website by the governing body)

- (a) The amount of the school's allocation from the Pupil Premium grant
- (b) in respect of the current academic year; details of how it is intended that the allocation will be spent; details of how the previous academic year's allocation was spent, and the effect of this expenditure on the educational attainment of those pupils at the school in respect of whom grant funding was allocated.

## Schools Causing Concern – statutory guidance for Local Authorities – May 2014

For the purpose of this guidance, a "warning notice" is one that is issued to the governing body of a maintained school by the local authority where one or more of the grounds in section 60(2)(a-c) are satisfied: unacceptably low standards of performance of pupils, serious breakdown in the way the school is managed or governed that is prejudicing (or likely to prejudice) standards of performance (this could include where there is evidence of very poor financial management), and/or safety of pupils or staff of the school is threatened.



# School Revenue Funding Formula

#### Background & Context

- 2013-14 1<sup>st</sup> year of new national funding arrangements
- LAs required to amend funding formula for 2013/14
- 2014-15 little change to the funding formula
- National Fair Funding Formula 2016-17 ???
- Maximise delegation and responsibility to schools

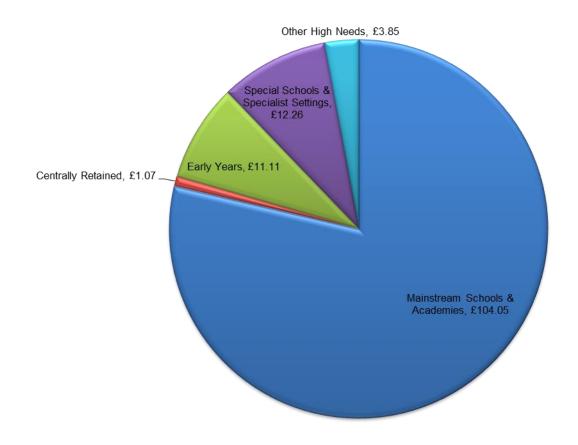
### **Background and Context**

## Key principles applied in developing the funding formula in both 2013-14 and 2014-15:

- (a) To minimise fluctuations in funding for schools as far as possible prior to the introduction of the national fair funding formula; and
- (b) To maintain the funding for each of the phases in the same proportion / percentage split for modelling purposes.

## School Revenue Funding Formula

**Funding of Mainstream Schools** 

- Funding Formula for Primary & Secondary Schools:
  - Now based on the October pupil census
  - National Formula with local choices
  - Portsmouth Formula comprises 8 funding factors
  - Combination of 'Pupil-led' and 'Non-pupil led' funding factors
  - Applies to Maintained Schools and Academies

#### Central Expenditure:

- In 2013-14 a number of expenditure budgets which were previously held centrally were delegated to schools.
- Most of these budgets have been de-delegated by approval of Schools Forum to central control on behalf of maintained schools.
- These budgets cannot be de-delegated from Academy Schools. Although Academies can buy certain services through Portsmouth's 'traded services' directory.

The amount of funding de-delegated is shown on your schools budget share statement.

### Mainstream Settings & Local Offer

- From September 2014, Schools and Academies are required to publish their 'local offer' which sets out the range of services available for children with disabilities and special educational needs.
- Schools and Academies are required to contribute up to the first £6,000 of the additional support costs of high needs pupils

### Mainstream Settings & Local Offer

- Additional support is the support required to enable a pupil to access the mainstream school or academy 'local offer'
- Funding above this level may be agreed through the 'Education Health & Care Plan' and if required paid as a top up.



## School Revenue Funding Formula

Funding of Special Schools & Specialist Settings

### Funding for Specialist Settings

- Special Schools and Resourced Units:
  - £10,000 place funding + Element 3 Top-up funding
- Alternative Provision:
  - £8,000 place funding + Element 3 Top up funding

## Funding for Specialist Settings

- Place Funding:
  - Maintained Schools: Allocated in full by internal journal in April.
  - Academy Schools: This will be paid directly to the school from the Education Funding Agency monthly.

## Funding For Specialist Settings

- Element 3 Top-Up funding:
  - Element 3 funding follows the pupil
  - Special School Banding system (A H)
  - Funding will fluctuate year-on-year (impact on annual budget)

## Funding for Specialist Settings

- Element 3 'Top Up' Funding (*where the LA is the commissioner*):
  - Maintained Schools: Estimated allocation termly in advance. Any adjustments will be made in the following terms allocation (except at year-end)
  - Academy Schools: Payment will be made monthly to Portsmouth Academies, with termly adjustments.
  - All schools: will be responsible for invoicing other LA's for 'Top-Up' funding relating to pupils in their schools.

#### **Alternative Provision**

- Place funding of £8,000
- Top Up funding and transport costs will be by the commissioner on a per pupil basis
- For early intervention, placements to avoid permanent exclusion, off site direction, or fixed period exclusion the commissioner will be the mainstream school or academy
- For permanent exclusions and other instances the commissioner will be the Local Authority

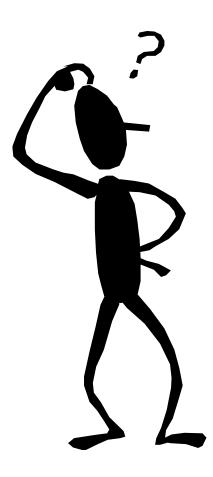
### Special Schools

# School Revenue Funding

**Grant Funding For Schools** 

### **Grant Funding**

- Grant Funding received by Schools & Academies in addition to the budget shares:
  - Universal Infant Free School Meals
  - Pupil Premium
  - Primary Sports Grant
  - Summer Schools
  - Catch-up Funding

- From September 2014, schools and academies will be required to offer a free lunch to every Primary School child in reception classes, year 1 and year 2.
- A 'provisional allocation' for the academic year 2014 to 2015 of the UIFSM grant will be issued by the DfE based on the January 2014 school census.

#### **Provisional Allocation** calculation:

- No. of pupils on roll in reception, Yr1 and Yr2
- Minus
- No. of pupils on roll in reception, Yr1 and Yr2 known to be eligible for FSM
- Equals the number of eligible pupils
- Multiplied by £2.30 x 190 x 87%

This means that each school will be allocated £380.19 for each pupil in reception, Yr1 and Yr2 not known to be eligible for FSM in January 2014

#### **Funding Example:**

- 100 pupils in reception, Yr1 and Yr2 Less
- 40 pupils who are already eligible for FSM
  - = 60 eligible pupils for UIFSM
- 60 pupils x £2.30 x 190 = £26,220
   = £26,220 x 87% = £22,811.40 Provisional Allocation
- $7/12^{ths}$  allocated in 2014-15 = £13,306.65

- A final allocation for Academic year 2014 to 2015 will be calculated in May 2015 from the October 2014 and January 2015 school censuses, using the following information:
- Total number of pupils on roll in reception, Yr1 and Yr2 who took a meal on the census dates,

minus:

 Total number of pupils on roll in reception, Yr1 and Yr2 known to be eligible for FSM on the census dates

#### Final Allocation calculation:

- The resulting total from the previous calculation will be divided by two.
- This figure will be multiplied by £2.30 x 190 (i.e £437)

#### **Funding Example:**

If pupil data remained unchanged:

- 100 pupils in reception, Yr1 and Yr2 all take meals
   Less
- 40 pupils who are already eligible for FSM
   = 60 eligible pupils for UIFSM
- 60 pupils x £2.30 x 190 = £26,220 = Final Allocation
- Final payment = £26,220 less £13,306.65 already paid
   = £12,913.35

#### **Funding Example:**

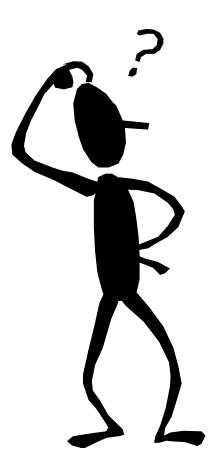
If pupil data changed:

- 70 pupils in reception, Yr1 and Yr2 take meals
   Less
- 40 pupils who are already eligible for FSM
   = 30 eligible pupils for UIFSM
- 30 pupils x £2.30 x 190 = £13,110 = Final Allocation
- Final payment = £13,110 less £13,306.65 already paid
   = £ (196.65)

#### Payment arrangements:

- June 14 7/12ths of each schools provisional main allocation. Schools who are Academies on 1 April 14, will receive their allocation from the Education Funding Agency (EFA)
- Spring 15 the final allocation for each maintained school as at April 15 minus the amount of the provisional allocation paid in June 14. Any school that converts to Academy between 1 April 14 and 1 April 15 will receive their final allocation from the EFA.

# Pupil Premium / Assessing The Impact

#### What is pupil premium?

- Introduced in April 2011
- Pupil premium is an additional grant allocation to support schools in raising the educational attainment of disadvantaged pupils.

#### **How is Pupil Premium allocated to Portsmouth?**

Pupils attracting PPG	£ per pupil
Free School Meals Pupils – Primary	1,300
Free Schools Meals Pupils – Secondary	£935
Looked After Children (LAC)	£1,900
Post - LAC	£1,900
Service Children	£300

#### How much Pupil Premium is allocated to Portsmouth?

Pupils attracting PPG	£m
Free School Meals Pupils – Primary	6.2
Free Schools Meals Pupils – Secondary	2.9
Looked After Children & Post LAC	0.4
Service Children	0.2

## PPG will be allocated to schools and academies as based on the January 14 census

## Pupil Premium Looked After Children

#### **PPG for Looked After Children (LAC)**

- The grant allocation for LAC must be managed by the Virtual School Head (VSH)
- The VSH is a statutory post under the Children's & Families Act 2014
- Funding will be allocated to Schools based on the requirement of the Personal Education Plan (PEP) which must be approved by the VSH.

#### Sept 2012 report - Ofsted Recommendations included:

- School leaders, including governing bodies, should ensure that Pupil Premium funding is not simply absorbed into mainstream budgets, but instead is carefully targeted at the designated children. They should be able to identify clearly how the money is being spent.
- School leaders, including governing bodies, should evaluate their Pupil Premium spending, avoid spending it on activities that have little impact on achievement for their disadvantaged pupils, and spend it in ways known to be most effective.

Sept 2012 report - Ofsted Recommendations included

 If schools do not target Pupil Premium money effectively, then government should consider ring fencing, payment lined to outcomes, or other mechanisms to improve its use.

Feb 2013 report – Ofsted findings

- Ofsted identified a number of consistent characteristics in schools where:
  - Pupil premium funding was successfully used to improve achievement
  - Pupil premium was being spent less successfully
