It is considered that the existing timber panes are in a poor state of repair that detract from the character and appearance of the conservation area; their replacement would modernise the appearance of the property but would be considered an appropriate enhancement to the overall character and appearance of the conservation area. It is considered that the existing balconies would not increase overlooking or result in a loss of privacy that is any greater than at present and this is not considered to be significant.</p> <p>Other representations have been received relating to the structural aspects of the glass partitions but these are not considered to be a material consideration in the determination of this application and other legislation exists to deal with this.
