**NOTIFICATION BY MEMBER OR CO-OPTED MEMBER  
OF  
PORTSMOUTH CITY COUNCIL  
OF DISCLOSABLE PECUNIARY INTERESTS**

I, Councillor Matthew Atkins being a Member of Portsmouth City Council hereby give notice that I, my spouse or civil partner, or someone I am living with as if we were husband and wife or civil partner ('partner') have the following disclosable pecuniary interests within the description set out in the Schedule to the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012, made by the Secretary of State in accordance with Section 30 of the Localism Act 2011 ('the Localism Act').

**1 Employment, Office, Trade, Profession or Vocation**

This means any employment, office, trade, profession or vocation carried on for profit or gain, of yourself, or your partner.

You should include any self-employment as well as where someone else employs you, or your partner.

<b>And of my spouse / civil partner (or person with whom I am living as such) of which I am aware.</b>

**2 Sponsorship**

This means any payment or provision of any other financial benefit (other than from Portsmouth City Council) made or provided to yourself, or your partner, within the period of 12 months ending on the date of this notification, in respect of any expenses incurred by yourself in carrying out your duties as a Member, or towards your election expenses.

This also includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992, Section 52.

<b>And of my spouse / civil partner (or person with whom I am living as such) of which I am aware.</b>

### 3 **Contracts**

This means any contract made between yourself, or your partner, (or a body in which you, or your partner, have a beneficial interest), and Portsmouth City Council -

- (a) under which goods or services are to be provided or works are to be executed; AND
- (b) which has not been fully discharged;

<b>And of my spouse / civil partner (or person with whom I am living as such) of which I am aware.</b>

### 4 **Land**

This means any beneficial interest in land within the area of Portsmouth City Council of yourself, or your partner.

This includes land which you, or your partner, own, lease, have the benefit of an option over, or have other rights in or over such as an easement or other burden or interest which carries the right to occupy land or receive income, or upon which you have a mortgage.

## 5 Licences

This means any licence (alone or jointly with others) to occupy land in the administrative area of Portsmouth City Council held by yourself, or your partner, for a month or longer.

<b>And of my spouse / civil partner (or person with whom I am living as such) of which I am aware.</b>

## 6 Corporate Tenancies

This means any tenancy where (to your knowledge) –

- (a) the landlord is Portsmouth City Council; AND
- (b) the tenant is a body in which you, or your partner, have a beneficial interest;

<b>And of my spouse / civil partner (or person with whom I am living as such) of which I am aware.</b>

## 7 Securities

This means any beneficial interest in securities of a body where –

- (a) that body (to your knowledge) has a place of business or land in the administrative area of Portsmouth City Council; AND
- (b) either -
  - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued shared capital of that body; OR
  - (ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which you, or your partner, have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Section 8, and other securities of any description, other than money deposited with a building society.

**N.B. A body in which you, your spouse/civil partner (or person with whom you are living as such) have a beneficial interest means a firm in which you, your spouse/civil partner (or person with whom you are living as such) is a partner, or a body corporate of which you, your spouse/civil partner (or person with whom you are living as such) is a director, or in the securities of which you, your spouse/civil partner (or person with whom you are living as such) has a beneficial interest.**

## 8 Personal Interests

You have a personal interest in the business of the Council when it relates to or is likely to affect:

- a. any body of which you are a member or in a position of general control or management, and to which you are appointed or nominated by the Council.
- b. any body
  - i. exercising functions of a public nature;
  - ii. directed to charitable purposes; or
  - iii. one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union); of which you are a member or in a position of general control or management
- c. any employment or business carried on by you other than for profit or gain;
- d. any person or body who employs you, or who has appointed you, other than for profit or gain;
- e. the interests of any person from whom you have received a gift or hospitality with an estimated value of at least £50 in the last three years; (Note: part e. is covered by a separate reporting process)

You also have a personal interest in the business of the Council when a decision in relation to that business might reasonably be regarded as affecting your well-being or financial position, or the well-being or financial position of a relevant person (as defined at paragraph 4.3 in the code), to a greater extent than the majority of other council tax payers, ratepayers or inhabitants of the electoral ward within the administrative area of the Council affected by the decision;

<b>And of my spouse / civil partner (or person with whom I am living as such) of which I am aware.</b>



I understand that failure (without reasonable excuse);

- (a) to register any disclosable pecuniary interest required to be registered under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act; or
- (b) to participate in any discussion or vote in any matter considered at a meeting where I have a disclosable pecuniary interest in the matter in contravention of Section 31(4) of the Localism Act; or
- (c) when acting as a single Executive Member take any steps other than for the purpose of enabling the matter to be dealt with by myself, in contravention of Section 31(8) of the Localism Act; or
- (d) knowingly or recklessly provide information under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act which is false or misleading;

is a criminal offence under Section 34 of the Localism Act,

punishable by a fine not exceeding level 5 on the standard scale (currently £5,000), and disqualification as a Member or Co-opted Member of Portsmouth City Council or any other relevant authority for a period not exceeding five years.
